A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, REPEALING ALL PREVIOUS RESOLUTIONS PERTAINING TO THE PROCEDURES FOR NAMING AND RENAMING OF PROPERTIES, FACILITIES, PARKS, STREETS AND MEMORIALS; IMPLEMENTING A NEW NAMING POLICY AND PROCEDURES, AND APPROVING THE ASSOCIATED APPLICATION.

WHEREAS, Subsection 155.14(H) of the City of Hollywood Code of Ordinances requires City Commission approval of naming and renaming of streets and City facilities and for establishment of application fees and procedures by resolution; and

WHEREAS, the City Commission adopted Resolutions R-2012-197 and R-2017-076; and

WHEREAS, staff has expressed an interest in updating the procedures, respective applications, and fees for the naming and renaming of streets and City facilities.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it repeals all previous Resolutions regarding the Procedures for the Naming and Renaming of Properties, Facilities, Parks and Memorials, namely: R-2012-197 and R-2017-076.

Section 3: That it approves the attached City of Hollywood Naming Policy and Procedures.

Section 4: That it approves the attached City of Hollywood Properties, Facilities, Parks, and Streets Naming Application.
