Mike,

I've attached the pdfs that contain the worksheets for the various locations where the subject signs have been recommended by our Traffic Calming consultant. I just reviewed the worksheets more carefully and saw that are actually 8 rather than 10 locations in Commission Districts 3, 4 and 5. The original

total of ten signs was based on a quick review of the Recommendations Summary sheets on the first page of each pdf. The summary for District 5 indicated that two (2) signs had been recommended for installation on Farragut Street between B. 72<sup>nd</sup> and N. 74<sup>th</sup> Avenue. However, the actual worksheet shows that only two speed tables are to be installed and no ESFB signs are recommended. I will contact our consultant to find out if this information was incorrectly transposed from another location but, at this point, a total of 8 signs has been recommended.

The specific worksheets for the ESFB signs can be found as follows:

**District 3:** N. 28<sup>th</sup> Avenue between Hollywood Boulevard and Johnson Street (pages 6, 7 and 8 of 17 in attached pdf) – 4 signs

**District 4:** N. 33<sup>rd</sup> Avenue/N. Park Road from Sheridan Street to Stirling Road (pages 6, 7, 8 of 10 in attached pdf) – 2 signs

**District 5:** N. 64<sup>th</sup> Avenue between Taft Street and Sheridan Street (pages 8, 9 and 10 of 15 in attached pdf) – 2 signs

I'll let you know what Atkins has to say about the D5 location on Farragut Street.

Farragut Street from N 72<sup>nd</sup> Ave to N 74 Ave – 2 signs
