This Amendment (“Amendment”), effective as of October 30, 2019, to the Cloud Solutions, Alternate Contract Source No. 43230000-NASPO-16-ACS (“Agreement” or “ACS”), between the State of Florida, Department of Management Services (“Department”) and SHI International Corp. (“Contractor”), are collectively referred to herein as the “Parties.” All capitalized terms used herein shall have the meaning assigned to them in the ACS unless otherwise defined herein.

WHEREAS, the Parties agreed that the ACS may be amended by mutual agreement as provided in section 6, Amendments, of the Participating Addendum;

THEREFORE, in consideration of the mutual promises contained below, and other good and valuable consideration, receipt, and sufficiency of which are hereby acknowledged, the Parties agree to the following:

I. Amendment to the Participating Addendum. The ACS is amended to replace section 1, Term and Effective Date, in its entirety with the following:
The initial term of this Participating Addendum will become effective on the date the document is signed by all Parties, and shall be effective through September 15, 2026, unless terminated earlier in accordance with the General Contract Conditions.

II. Conflict. To the extent any of the terms of this Amendment conflict with the terms of the ACS, the terms of this Amendment shall control.

III. Warranty of Authority. Each person signing this Amendment warrants that he or she is duly authorized to do so and to bind the respective party.

Effect. Unless otherwise modified by this Amendment, all terms and conditions contained in the ACS shall continue in full force and effect. This Amendment sets forth the entire understanding between the parties with regard to this subject matter hereof.
