## RESOLUTION NO.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE A BLANKET PURCHASE ORDER WITH PRO SECUR INC. FOR UNIFORMED, ARMED AND UNARMED SECURITY GUARD SERVICES – CITYWIDE FOR AN ESTIMATED ANNUAL EXPENDITURE OF \$384,194.00.

WHEREAS, the Police Department, Public Utilities Department, the Office of Parking and the Department of Parks, Recreation and Cultural Arts require a contract for Uniformed, Armed and Unarmed Security Guard Services at their facilities; and

WHEREAS, Bid Number F-4551-17-PB was created and posted in BidSync on March 23, 2017, for Armed and Unarmed Security Services; and

WHEREAS, Regions Security Services, Inc. ("Regions") was awarded a contract for a two year initial term with three one-year renewals; and

WHEREAS, City stakeholders have recommended termination for convenience of the Regions contract; and

WHEREAS, Pro Secur Inc. was found to be the next lowest responsible, responsive bid for Bid F-4551-17-PB; and

WHEREAS, no provisions were outlined in Bid F-4551-17-PB to allow for rankings of vendors to be considered should a contract be terminated; and

WHEREAS, Pro Secur has agreed to provide security services outlined in the specifications of Bid F-4551-17-PB and has agreed to maintain their pricing provided with their proposal; and

WHEREAS, Pro Secur will maintain the required liability amount set forth in in Bid F 4551-17-PB; and

WHEREAS, Pro Secur has provided satisfactory past performance of security services; and

WHEREAS, funding the Blanket Purchase Agreement will be provided in the fiscal year 2019 budget in various Account Numbers and will be budgeted in the next subsequent fiscal year; and WHEREAS, under Procurement Code Section 38.40(C)(8), purchases of contractual services, when the City Commission declares by a 5/7ths vote that competitive bidding and competitive proposals are not in the best interest of the City, are exempt from competitive bidding and competitive proposal requirements.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves and authorizes the issuance, by the appropriate City officials, of a Blanket Purchase Agreement with Pro Secur, in a form acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.

<u>Section 3</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
