WHEREAS, teacher member Vincent Newman was removed due to absences, and his term expires June 30, 2025; and

WHEREAS, teacher member Jeffrey Freeman passed away, and his term expires June 30, 2026; and

WHEREAS, regular members Jamil Richards and Valorie Weldon have terms that expire on June 30, 2025; and

WHEREAS, regular members Candace Beeber and Susan Edwards were removed due to absences; and their terms expire on June 30, 2025 and June 30, 2026 respectively; and

WHEREAS, regular member Mateo Watson was removed at the recommendation of the City Manager and approved by a 7-0 vote of the City Commission on April, 4, 2025, and his term expires on June 30, 2025; and

WHEREAS, one regular member position remained unfilled in June 2024, and its term expires June 30, 2025; and

WHEREAS, student alternate members David Liebowitz and Brook Manasse have terms that expire on June 30, 2025; and

WHEREAS, the City Clerk provided notice to the public that positions are available on the Committee and solicited interest forms from citizens to fill available vacancies; and
