A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO RENEW BLANKET PURCHASE AGREEMENT NO. PA600319 FOR A ONE-YEAR TERM WITH MBR CONSTRUCTION, INC. FOR SIDEWALK CONSTRUCTION SERVICES IN AN AMOUNT NOT TO EXCEED \$2,501,545.00 IN ACCORDANCE WITH SECTION 38.49(C)(1) OF THE PROCUREMENT CODE (RENEWALS).

WHEREAS, on March 3, 2021, the City Commission passed and adopted Resolution No. R-2021-057, approving the attached Blanket Purchase Agreement in an amount not to exceed \$2,501,545.00 with MBR Construction, Inc. for sidewalk construction services for an initial term from March 3, 2021 to November 9, 2022, with an option to renew for one additional one-year period based upon Broward County's Contract PNC21212019B1; and

WHEREAS, Broward County has renewed its contract for a one-year term effective November 10, 2022 to November 9, 2023; and

WHEREAS, the Department of Development Services' Engineering, Transportation and Mobility Division desires to renew Blanket Purchase Agreement No. PA600319 with MBR Construction, Inc. for the one-year period from November 10, 2022 to November 9, 2023, in an amount not to exceed \$2,501,545.00; and

WHEREAS, Section 38.49(C)(1) of the Procurement Code states that when a contract entered by the City pursuant to City Commission approval provides for one or more renewals by affirmative action of the City and the estimated annual cost of a renewal exceeds \$250,000, only the City Commission is authorized to approve such renewals, which includes this desired renewal; and

WHEREAS, the Director of the Department of Development Services and the City Engineer recommend that the City Commission approve and authorize the one-year renewal of the attached Blanket Purchase Agreement with MBR Construction, Inc. in an amount not to exceed \$2,501,545.00; and

WHEREAS, funding for the renewal of Blanket Purchase Agreement No. PA600319 is available in account number 116.160502.51900.583440.001247.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the appropriate City officials to renew the attached Blanket Purchase Agreement No. PA600319 with MBR Construction, Inc., together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
