Explanation:

This Resolution seeks to authorize the appropriate city officials to issue a blanket purchase order between Delta Property Maintenance, Inc. and the City of Hollywood to provide janitorial services for Fire Rescue Station 74 for an initial two-year period in the estimated amount of \$65,180.00 with two (2) additional one (1) year periods. Pursuant to §38.50 of the Hollywood Code of Ordinances, the City has determined that this bid shall be set aside for participation by local Hollywood vendors only.

On March 3, 2014, Notices of Set-Aside Bid F-4412-14-JE were mailed and electronically advertised on the City's website and Demandstar in accordance with §38.42(A)(1) of the City's Purchasing Ordinance. On March 27, 2014, Set-Aside Bid F-4412-14-JE was opened and resulted in responses from six (6) bidders:

Weed-A-Way, Inc., Hollywood, Florida	\$85,580.00

Pro-Active Janitorial, Hollywood, Florida	\$449,280.00

After evaluation it was determined that Bright Maintenance, Inc. was considered nonresponsive due to inadequate references and Delta Property Maintenance was selected as the lowest responsive bidder. This award is subject to the vendor indemnifying the City and the City receiving all insurance required and approved by the City's Risk Manager

Funding has been appropriated in the Building Maintenance Account Number 01.2151.00000.522.004635 in the Proposed FY 2015 Budget, and will be available subject to passage and adoption by the City Commission. Payments will be available to be made from this account on or after October 1, 2014. Funding will be requested in subsequent years.
