

South Florida Water Management District (SFWMD) Compliant Code Changes

City Code changes to comply with FAC 40E-24, Year-Round Irrigation Rule. Primary changes:

1. Permanent year-round restrictions on times and number of days irrigation is allowed
 - a) Sprinklers only twice/week (currently only restricted during declared droughts)
 - a) Even addresses- Thursday and Sunday
 - b) Odd addresses- Wednesday and Saturday
 - b) No daytime watering (9 am to 5 pm)

SFWMD Compliant Code Changes

New Irrigation Code	Current Irrigation Code
Permanent year-round restrictions	Restrictions only apply during SFWMD issued Droughts
Sprinklers only allowed twice weekly: Even addresses- Thursday and Sunday Odd addresses- Wednesday and Saturday	Same restrictions but again only apply during declared droughts
No daytime watering (9 am to 5 pm)	New requirement
Numerous additional exclusions and exceptions- see next page	New exclusions and exceptions added

SFWMD Irrigation Code Changes (Continued)

Other changes:

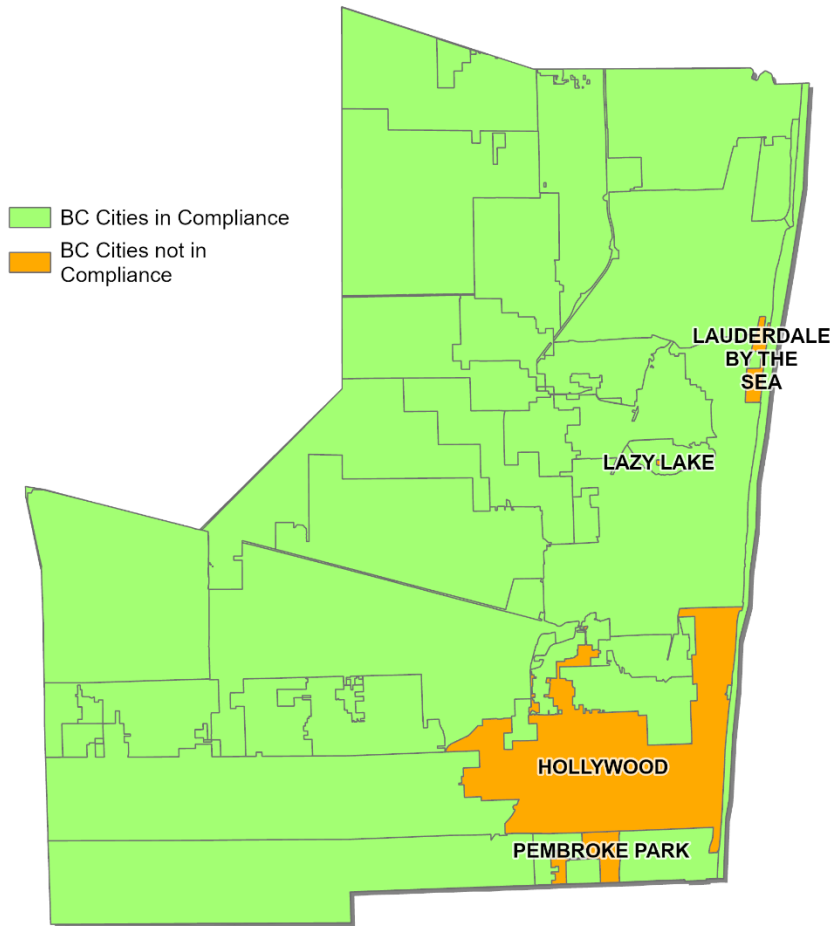
1. Exceptions for:
new plantings, testing of equipment,
watering-in periods, waivers, variances
2. Excluded from rule:
reuse and harvested water; agricultural
usage, low-volume irrigation (micro, hand
watering)
3. Definitions have been updated

Irrigation Code Change History

- Chapter 51 Water
 - 2010- SFWMD initiates permanent irrigation changes for the entire district
 - 2010- Broward County adopts SFWMD changes
 - 2019- SFWMD requests Hollywood (and other cities in the district) adopt these changes
 - 2020- Debra Reese/DPU develop draft changes; item on Nov 2020 Agenda, pulled before meeting in part due to flooding at the time

Impacts of Non-Compliance

- SFWMD has oversight or control of:
 - Consumptive Use Permit (CUP)
 - Water Supply Plan
 - Stormwater Plan
 - Grants and Loans
