A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A HIGHWAY MAINTENANCE MEMORANDUM OF AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION FOR TAFT STREET IMPROVEMENTS.

WHEREAS, Taft Street is part of the City of Hollywood's Roadway System; and

WHEREAS, pursuant to Sections 339.07, 339.08 and 339.12, Florida Statutes and Federal funding provisions the Florida Department of Transportation ("FDOT") is authorized to undertake projects within a city's geographical limits; and

WHEREAS, pursuant to such authority, FDOT and the City agree to have FDOT design, permit and construct certain improvements along Taft Street from State Road 7 to N 40th Avenue; and

WHEREAS, these improvements include milling and resurfacing, minor widening, shared use path installation, tree disposition, lighting, drainage and signing and pavement marking ("Project"); and

WHEREAS, FDOT has obtained Federal funding approval for the Project and the CITY is responsible for additional Project costs determined to be Federal Aid Non-Participating; and

WHEREAS, FDOT may not spend State funds for off-system projects and there must be an agreement between FDOT and the City to maintain the project after construction; and

WHEREAS, funding for future maintenance of the improvements will be budgeted in subsequent fiscal years' operating budgets subject to approval and adoption by the City Commission; and

WHEREAS, the City Manager recommends that the City Commission approve the execution of Highway Maintenance Memorandum of Agreement for Taft Street Improvements.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AMENDMENT NO. 14 TO THE LANDSCAPE INCLUSIVE MAINTENANCE MEMORANDUM AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION TO INCLUDE THE HOLLYWOOD BOULEVARD STREETScape IMPROVEMENTS.

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the execution, by the appropriate City officials, of the attached Highway Maintenance Memorandum of Agreement with the Florida Department of Transportation, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
