A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, RATIFYING THE CITY MANAGER'S APPROVAL OF A PURCHASE ORDER WITH LANZO CONSTRUCTION CO., FLORIDA FOR THE EMERGENCY REPAIR OF A 72-INCH GRIT CHAMBER EFFLUENT PIPE IN AN AMOUNT UP TO \$425,580.00, PURSUANT TO SECTION 38.41(C)(1) OF THE CITY'S PROCUREMENT CODE; APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN AUTHORIZATION TO PROCEED FOR WORK ORDER NUMBER H&S 23-07 WITH HAZEN AND SAWYER, P.C. IN AN AMOUNT UP TO \$31,611.00 FOR CONSTRUCTION ADMINISTRATION SERVICES FOR THIS PROJECT.

WHEREAS, on April 17, 2023, a progressive collapse in the pavement between the Grit Chamber and the Influent Pump Station was observed at the Southern Regional Wastewater Treatment Plant ("SRWWTP"), and Department of Public Utilities ("Department") staff sequestered the sinkhole and surrounding area for safety; and

WHEREAS, on April 18, 2023, Department staff arranged for CCTV and diver inspections of the pipe under the collapsed area, which revealed an approximately 12inch hole in the pipe crown; and

WHEREAS, on May 2, 2023, considering the extensive loss of pipe material observed during the inspection and the potential imminent collapse of this pipe, Hazen and Sawyer, P.C. ("H&S"), the Department's consultant, recommended the City initiate an emergency repair using either cured-in-place pipe lining or slip-lining techniques; and

WHEREAS, H&S also confirmed that Lanzo Construction Co., Florida ("Lanzo") and Insituform Technologies, LLC are the only two contractors in South Florida qualified to repair this size pipe with the recommended method; and

WHEREAS, on May 10, 2023, after several meetings with both contractors, Department staff received only one bid, with the following results:

WHEREAS, Section 38.41(C)(1) of the Procurement Code exempts from competitive bid and competitive proposals emergency purchases that receive prior administrative approval except for the most urgent situations presenting a clear and present substantial threat to life or property where immediate action is required; and

WHEREAS, on May 18, 2023, pursuant to Section 38.41(C)(1) of the Procurement Code, the City Manager approved and authorized an emergency purchase order with Lanzo for the emergency repair of the 72-inch pipe in an amount up to \$425,580.00, based upon Memo No. PU-23-90; and

WHEREAS, on September 20, 2017, the City Commission passed and adopted Resolution No. R-2017-283, which authorized the execution of continuing professional consulting engineering services contracts with four firms for the Water Treatment Plant and SRWWTP projects, one of the firms being H&S; and

WHEREAS, on August 9, 2021, the continuing services contract with H&S was renewed for another two-year period; and

WHEREAS, the Department requested a proposal from H&S to provide construction administration services for this project; and

WHEREAS, H&S submitted a proposal to provide construction administration services in an amount up to \$31,611.00; and

WHEREAS, Department staff evaluated the scope and fee proposal and determined that the negotiated fee was fair and reasonable and in accordance with industry standards; and

WHEREAS, the Department Director and the Chief Procurement Officer recommend that the City Commission ratify the City Manager's approval of the issuance of a purchase order to Lanzo for construction services related to the emergency repair of the 72" Grit Chamber Effluent Pipe in an amount up to \$425,580.00, and to approve the execution of the Authorization to Proceed for Work Order No. H&S 23-07 with H&S in an amount up to \$31,611.00 for construction administration services for this project; and

WHEREAS, funding for this service will be made available in a new account number subject to the approval of a companion budget amendment resolution; and

WHEREAS, Lanzo commenced shop drawing submittal and other construction work on April 17, 2023 and is expected to complete the repair by October 10, 2023.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it ratifies the City Manager's approval of a purchase order with Lanzo Construction Co., Florida, for the emergency repair of a 72-inch Grit Chamber Effluent Pipe in an amount up to \$425,580.00, pursuant to Section 38.41(C)(1) of the City's Procurement Code (Emergency Purchases).

Section 3: That it approves and authorizes the execution, by the appropriate City officials, of the attached Authorization to Proceed for Work Order Number H&S 23-07 with Hazen and Sawyer, P.C., together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form by the City Attorney.

<u>Section 4</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
