A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A BLANKET PURCHASE AGREEMENT WITH PYROTECNICO FIREWORKS, INC. FOR OFFSHORE FIREWORKS DISPLAY SERVICES IN AN ANNUAL AMOUNT UP TO \$140,000.00.

WHEREAS, the Department of Parks, Recreation and Cultural Arts desires to purchase an Offshore Fireworks Display for the City's annual July 4th Celebration to be held on Hollywood Beach; and

WHEREAS, Section 38.43 of the Procurement Code states that when the estimated annual cost of goods, supplies, materials, equipment, or services exceeds \$50,000.00, a formal solicitation process shall be completed that may result in a written contract(s) and/or purchase order(s) after due public notice inviting bids or proposals; and

WHEREAS, on January 25, 2024, Request for Proposals No. RFP-165-24-GJ ("RFP") was electronically advertised on OpenGov.com to solicit the desired Offshore Fireworks Display Services in accordance with Section 38.43(A) of the Procurement Code; and

WHEREAS, the RFP resulted in proposals from the following two firms by the response due date:

Alpha Fireworks, LLC (Spring Hill, Florida)

Pyrotecnico Fireworks, Inc. (St. Petersburg, Florida); and

WHEREAS, on April 10, 2024, the Selection Committee met to evaluate and rank the proposals based upon the following approved Evaluation Criteria established in the RFP: Firm/Organizational Profile; Qualifications & Experience; Project Understanding; Proposed Approach & Methodology; References, and Pricing; and

WHEREAS, based on the Evaluation Criteria, the Selection Committee evaluated the two proposals and the scores were compiled to arrive at the following rankings, with the highest score being the highest ranked:

1. Pyrotecnico Fireworks, Inc. 81.76 Points

2. Alpha Fireworks, LLC 57.33 Points; and

WHEREAS, the Selection Committee recommends that the City Commission authorize the negotiation and execution of a Blanket Purchase Agreement with the highest

ranked firm, Pyrotecnico, Inc., for a three-year term, for an annual amount up to \$140,000.00 for the first two years, an annual amount up to \$147,000.00 for the third year, with an option to renew for one additional three-year period to provide Offshore Fireworks Display Services; and

WHEREAS, funding for the Blanket Purchase Agreement is available in account number 001.300601.57200.549110.000000.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

That the foregoing "WHEREAS" clauses are ratified and confirmed Section 1: as being true and correct and are incorporated in this Resolution.

That it approves the ranking of the firms as follows: Section 2:

- 1. Pyrotecnico Fireworks, Inc.
- Alpha Fireworks, LLC

Section 3: That it authorizes the appropriate City officials to negotiate and execute a Blanket Purchase Agreement with Pyrotecnico Fireworks, Inc., together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form by the City Attorney.

That if the appropriate City officials are unable to negotiate a Blanket Section 4: Purchase Agreement with the highest ranked firm, they are authorized to terminate negotiations with that firm and proceed to negotiate and execute a Blanket Purchase Agreement with the next highest ranked firm until an agreement is reached.

Section 5: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
