The Evaluation Committee consisting of five (5) City employees met to review, discuss and evaluate the nine (9) responsive proposals received for a qualified engineering firm to provide a Continuing Contract for Structural Engineering Services (PW-14-009) for Public Works/Engineering based upon the RFQ's purpose, scope, system requirements and initial evaluation criteria.

The RFQ document's Consultant Selection Process requires an initial evaluation committee to review and score/rank the responsive proposals based upon the Initial Selection Criteria by which a minimum of three (3) firms will be shortlisted for oral interviews.

After review, discussion and evaluation of the nine (9) responsive RFQ submittals received, the Evaluation Committee unanimously recommended the following:

The evaluation committee scored and ranked the nine (9) responsive RFQ submittals with the five (5) highest ranked proposers being shortlisted as follows. (Matrix attached).

Agreed that they would like to have oral presentations scheduled from the five (5) highest ranked proposers who were shortlisted to further evaluate their RFP submittals as specified in the RFQ document.

The evaluation of the oral presentations was based upon the following criteria as established in the RFQ: Knowledge of sites and local conditions, Proposed project staff functions, Overall approach and methodology, Design philosophy and concepts, Cost control and value engineering and Schedule for projects.

The oral presentations were evaluated and the scores were compiled to arrive at the following rankings, (highest score), first choice to fifth choice (matrix attached):

The RFQ document stated that, the Department of Public Works, pursuant to Florida State Statute 287.055, Consultants Competitive Negotiation Act, is seeking to engage the services and enter into a continuing contract with up to three (3) qualified engineering firms to provide mechanical, electrical and plumbing engineering design services on an as needed basis for miscellaneous City projects as authorized by individual Consultant's Authorization to Proceed for individual projects.

The evaluation committee agreed that the RFQ submittals received from Lakdas/Yohalem Engineering, Inc., TRC Worldwide Engineering, Inc. and DeRose Design Consultants would best meet the City's operational needs.

The evaluation committee requested that Procurement move forward with the RFP award process by preparing a resolution for the City Commission based upon their recommendation to award contracts to the three (3) highest ranked firms.

Procurement Services will prepare a resolution and will also notify the three (3) highest ranked responsive proposers of the date and time of the City Commission meeting on which the award resolution is scheduled on the agenda.
