A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD. FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO APPLY FOR AND IF ACCEPT FY2015 BULLETPROOF AWARDED VEST PARTNERSHIP PROGRAM GRANT FUNDS FROM THE BUREAU JUSTICE ASSISTANCE THE OF IN APPROXIMATE AMOUNT OF \$48,945.04 AS PARTIAL REIMBURSEMENT FOR THE PURCHASE OF BULLETPROOF VESTS; **AUTHORIZING** THE CONTRIBUTION OF FEDERAL LAW ENFORCEMENT FORFEITURE FUNDS, PURSUANT TO THE FEDERAL COMPREHENSIVE CRIME CONTROL ACT OF 1984, IN AMOUNT THE APPROXIMATE OF \$48,945.04 AS REQUIRED MATCHING FUNDS FOR THIS PURPOSE: AND FURTHER AUTHORIZING, UPON SAID GRANT AWARD, THE EXECUTION OF AN AWARD AGREEMENT BY THE APPROPRIATE CITY OFFICIALS IN ORDER TO ACCEPT SAID GRANT FUNDS, AT NO COST TO THE CITY; THE DEPARTMENT AUTHORIZING OF FINANCIAL SERVICES TO ESTABLISH ACCOUNT(S) AS MAY BE NEEDED; AND FURTHER **AUTHORIZING** THE RECOGNITION OF REVENUE AND APPROPRIATION OF NET ASSETS IN FUND 12 TO THOSE ACCOUNTS.

WHEREAS, the bulletproof vest is required safety gear for Police Officers and the partial grant fund reimbursement helps to defray the costs for the purchase of new bulletproof vests; and

WHEREAS, grant funds for the award period FY2015, in the amount of \$48,945.00 together with \$48,945.04 in matching Federal Law Enforcement Forfeiture Funds will be used as reimbursement for the purchase of new bulletproof vests; and

WHEREAS, the Police Department desires to apply for FY2015 Bulletproof Vest Partnership Program grant funds to once again supplement the purchase of new bulletproof vests with the matching balance for this purchase derived from Federal Law Enforcement Forfeiture Funds: and

WHEREAS, the Department of Justice's Equitable Sharing Guidelines (Guidelines) sets forth that Federal Law Enforcement Forfeiture Funds may be expended on permissible uses such as law enforcement equipment which includes body armor; and

WHEREAS, the Guidelines require that the Police Department obtain approval for such expenditures from the City Commission; and

WHEREAS, the Chief of Police recommends the appropriate City Officials apply for and if awarded accept FY2015 Bulletproof Vest Partnership Program grant funds from the Bureau of Justice Assistance as partial reimbursement for the purchase of new bulletproof vests in an approximate amount of \$48,945.04, authorizing the contribution of Federal Law Enforcement Forfeiture Funds in an approximate amount of \$48,945.04 as required matching funds for this purpose, and further authorizing, upon said grant award, the execution of an Award Agreement by the appropriate City Officials in order to accept said grant funds, at no cost to the City; and

WHEREAS, the purchase of the bulletproof vests shall be in accordance with the City's Purchasing Ordinance;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That it hereby approves and authorizes the appropriate City Officials to apply for, and if awarded, accept FY2015 Bulletproof Vest Partnership Program grant funds from the Bureau of Justice Assistance.

<u>Section 2</u>: That it hereby approves and authorizes the contribution of required matching funds from the Federal Law Enforcement Forfeiture Fund for the FY2015 Bulletproof Vest Partnership Program grant.

Section 3: That the City Manager is hereby authorized to accept said grant, if awarded; provided, however, the City Manager shall have the discretion to refuse the grant in those circumstances where he determines it is in the best interest of the City to do so in which case he shall advise the City Commission of his intention to refuse the grant.

<u>Section 4</u>: That it hereby approves and authorizes the execution, by the appropriate City Officials, upon said grant award, of an Award Agreement accepting FY2015 Bulletproof Vest Partnership Program grant funds from the Bureau of Justice Assistance and the grant award conditions contained therein in a form acceptable to the City Manager and approved as to form and legality by the City Attorney.

<u>Section 5</u>: That it hereby authorizes the Department of Financial Services to create certain accounts to recognize revenue and appropriate program funding.
