#### B. SCOPE of SERVICE for BURGLAR & FIRE ALARM MONITORING

Burglar & Fire Alarm Monitoring Service shall be on a twenty four (24) hour/seven(7) day per week basis & shall include all labor to perform these services. Immediately retransmit the alarm to City of Hollywood Dispatch technician to the protected premises to arrive within two (2) hours of receipt of a signal where equipment needs to be manually reset by Zimy Electronics. Upon receipt of trouble signals or other signals pertaining to the monitoring and maintenance of these systems, provide notification to the City of Hollywood with a full report of each alarm with actions taken and verification that service has been restored. This shall include the nature of the interruption, time of occurrence & restoration of service.

#### SUPERVISOR SIGNAL:

Communicate immediately with the City of Hollywood.

If authorized by City staff, a technician shall be dispatched to investigate unless system restores to normal. (arrival time not to exceed four (2) hours.

Provide notification to the City of Hollywood of each alarm with actions taken & verification that service has been restored.

#### CENTRAL STATION:

Central Station service shall meet general requirements of the NFPA 72 Nation Fire Alarm Code, current Edition, as indicated in NFPA 72 and shall be fully functional on a twenty four (24) hour/seven (7) day per week basis.

The Central Station must be able to identify the location of the caller including facility, address & specific alarm if more than one at a facility.

Zimy Electronics shall comply with the requirement of the Florida Administrative Code, Rule 69A-48 Fire Safety Standards for Fire Alarm Systems, where applicable. In the event codes change, Zimy is required to comply with the most recent changes. All work performed & all equipment installed shall be in compliance with FS633.0.

Alarm signals initiated by pull stations, automatic fire detectors, water flow from the automatic sprinkler system, or actuation of other fire suppression systems or equipment shall be treated as activated fire alarms.
