Proposed Legislation:

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE A PURCHASE ORDER BETWEEN THUNDER DEMOLITION INC. AND THE CITY OF HOLLYWOOD FOR THE DEMOLITION OF 1203 N. FEDERAL HIGHWAY IN AN ESTIMATED AMOUNT OF \$49,000.00.

Explanation:

This Resolution seeks to authorize the appropriate City Officials to execute and issue a purchase order to Thunder Demolition Inc. from the City of Hollywood for demolition services to be provided in demolishing the building/structure existing at 1203 N. Federal Highway which was acquired by the City pursuant to Resolution R-2014-312 adopted and approved on October 15, 2014.

On April 13, 2015, a Notice of Bid Availability numbered F-4456-15-RL was posted which solicited bid responses from qualified, interested parties for demolition services at 1203 N. Federal Highway. On May 7, 2015, bid responses from seven (7) interested bidders were opened, evaluated, and scored by City staff. Two (2) of the bid responses were deemed to be non-responsive by failing to meet certain conditions of the bid document. Of the remaining five (5) bids received by the City, it was determined that Thunder Demolition Inc. had submitted the lowest, responsive and responsible bid in

the amount of \$49,000.00 for the demolition services to be provided excluding asbestos abatement. A recommendation to award the bid to Thunder Demolition Inc. has been prepared for the consideration of the City Commission.

Funding for the demolition services to be provided in the demolition of the structure/building located at 1203 N. Federal Highway will be provided through an amendment to the FY 2015 Capital Improvement Plan transferring funding from the approved FY 2015 Capital Improvement Plan as described in a companion item, Resolution R-2015-_____, to a line item to be established by the Department of Financial Services relating to the demolition project, subject to the adoption and approval by the City Commission of the said companion item.
