ORDINANCE NO. _____

AN ORDINANCE OF THE CITY OF HOLLYWOOD, FLORIDA, AMENDING SECTION 37.01 OF THE CODE OF ORDINANCES TO ADD THE BUILDING DEPARTMENT AS AN ADMINISTRATIVE DEPARTMENT AND TO CHANGE THE NAME OF THE DEPARTMENT OF PLANNING AND DEVELOPMENT SERVICES.

WHEREAS, currently the City's Building Division is within the Department of Planning and Development Services; and

WHEREAS, JRD & Associates, Inc. was retained to review the organizational operation of the Building Division; and

WHEREAS, on February 5, 2014, a presentation was made to the City Commission to discuss JRD & Associates, Inc.'s recommendations and the Chief Building Official's innovations and initiatives; and

WHEREAS, based upon the presentation, the City Manager recommends that the City Commission adopt an ordinance to separate the Building Division from the Department of Planning and Development Services and establish the Building Department as an administrative department of the city and to change the name of the Department of Planning and Development Services;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That Section 37.01 of the Code of Ordinances is hereby amended as follows:

§37.01 ADMINISTRATIVE DEPARTMENTS.

- (A) There are established the following administrative departments in the city:
 - (1) Department of Parks, Recreation and Cultural Arts;
 - (2) Department of Financial Services;
 - (3) Department of Fire-Rescue and Beach Safety;
 - (4) Police Department;
 - (5) Department of Public Utilities;
 - (6) Department of Community and Economic Development;
 - (7) Department of Planning and Development Services;
 - (8) Department of Public Works; and
 - (9) Department of Information Technology; and
 - (10) Building Department.

<u>Section 2</u>: That it is the intention of the City Commission and it is hereby ordained that the provisions of this section shall be made a part of the Code of Ordinances of the City of Hollywood, Florida, and the sections of this Code may be renumbered to accomplish such intention.

<u>Section 3</u>: That if any word, phrase, clause, subsection or section of this ordinance is for any reason held unconstitutional or invalid, the invalidity thereof shall not affect the validity of any remaining portions of this ordinance.

<u>Section 4</u>: That all sections or parts of sections of the Code of Ordinances, all ordinances or parts of ordinances, and all resolutions in conflict herewith by and the same are hereby repealed to the extent of such conflict.

CHAPTER 37 OF THE CODE OF ORDINANCES (AMENDING SECTION 37.01 TO ADD THE BUILDING DEPARTMENT AND CHANGE NAME OF DEPARTMENT OF PLANNING AND DEVELOPMENT SERVICES)
