

RESOLUTION NO. R-2017-323

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO APPLY FOR AND IF AWARDED, ACCEPT THE BROWARD METROPOLITAN PLANNING ORGANIZATION'S (BROWARD MPO) COMPLETE STREETS AND OTHER LOCALIZED INITIATIVES PROGRAM AWARD, IN AN AMOUNT NOT TO EXCEED \$2,000,000.00 PER AREA/ZONE TO IMPLEMENT COMPLETE STREETS AND OTHER LOCALIZED INITIATIVES PROGRAM WITHIN FOUR GEOGRAPHICAL AREAS ADJACENT TO THE STATE ROAD 7/US441 CORRIDOR DESCRIBED AS: 1) BEVERLY PARK SIDEWALK NETWORK, 2) HOLLYWOOD BEACH HEIGHTS & HOLLYWOOD COUNTRY ESTATES SIDEWALK NETWORK, 3) SHERIDAN PARK & HOLLYWOOD ACRES SIDEWALK NETWORK AND 4) WEST PARK ROAD BIKE LANE FROM US 441 TO JOHNSON STREET; FOR A TOTAL ESTIMATED PROJECT COST OF \$8,000,000.00; AND IF SUCCESSFULLY AWARDED, COMMITTING THE CITY TO FUND \$960,000.00 (12%) OF TOTAL COST FOR PROJECT CONTINGENCIES TOGETHER WITH THE APPLICABLE OPERATING AND MAINTENANCE COSTS ONCE COMPLETE; AND FURTHER AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE ANY AND ALL APPLICABLE PROGRAM DOCUMENTS AND AGREEMENT(S).

WHEREAS, the Broward Metropolitan Planning Organization (Broward MPO) has adopted Commitment 2040, their Long Range Transportation Plan (LRTP); and

WHEREAS, this set the stage for a new, more streamlined program for funding local mobility projects; and

WHEREAS, the Broward MPO has, as a result, established the Complete Streets and Other Localized Initiatives Program; and

WHEREAS, the Broward MPO requests a Resolution of support from the City in order for an application to be accepted and evaluated for ranking; and

WHEREAS, if awarded, this funding will partially fund Complete Streets Projects along City maintained local streets bordered by the State Road 7 corridor within the following four 4) areas/zones: 1) Beverly Park Sidewalk Network (Florida's Turnpike to

the west, State Road 7 to the East, Pembroke Road to the south, and Washington Street to the North) 2) Hollywood Beach Heights & Hollywood Country Estates Sidewalk Network (State Road 7 to the West, North 56th Avenue to the East, Johnson Street to the South, and Taft Street to the North) , 3) Sheridan Park & Hollywood Acres Sidewalk Network (State Road 7 to the West, North 56th Avenue to the East, Taft Street to the South, Sheridan Street to the North); and 4) West Park Road Bike Lane from SR 7 to Johnson Street ; and

WHEREAS, the City of Hollywood endorses the Beverly Park Sidewalk Networks, Hollywood Beach Heights & Hollywood Country Estates Sidewalk Network, Sheridan Park & Hollywood Acres Sidewalk Network and West Park Road Bike Lane from SR7 to Johnson Street projects, to receive funding from the Broward County Metropolitan Planning Organization's Complete Streets and other Localized Initiatives Program (CSLIP); and

WHEREAS, the City of Hollywood endorses the Florida Department of Transportation (FDOT) delivering the Beverly Park Sidewalk Networks, Hollywood Beach Heights & Hollywood Country Estates Sidewalk Network, Sheridan Park & Hollywood Acres Sidewalk Network and West Park Road Bike Lane from SR7 to Johnson Street projects on the City's behalf, fully administering the design and construction phases of the project; and

WHEREAS, if the City is successful in the grant application, the City commits to funding \$960,000.00 (12%) of total cost in the first year required which is anticipated to be FY 2020; and

WHEREAS, said grant match would be part of the City's annual adopted Capital Program which is subject to the approval of the City Commission; and

WHEREAS, if the City is successful in the grant application project related accounts would be needed to be established by the Department of Financial Services; and

WHEREAS, the City will assume the responsibility to maintain or coordinate the maintenance of the improvements after the project's completion;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby authorizes the appropriate City Officials to apply for the Broward MPO's Complete Streets and Other Localized Initiatives Program for funding in the amount of \$2,000,000.00 for each of the four (4) Complete Streets Projects within the above referenced areas/zones along the State Road 7 corridor, ranked for award in the order listed below for a total estimated project cost of \$8,000,000.00:

1. Beverly Park Sidewalk Network

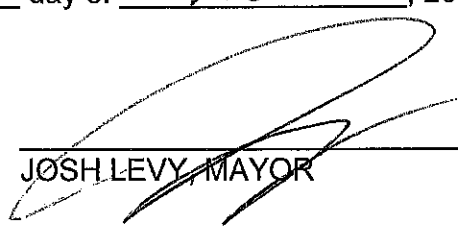
2. Hollywood Beach Heights & Hollywood Country Estates Sidewalk Network
3. Sheridan Park & Hollywood Acres Sidewalk Network
4. West Park Road Bike Lane from SR7 to Johnson Street

Section 2: That the City Manager is hereby authorized to accept said funding, if awarded; provided, however, the City Manager shall have the discretion to refuse the funding in those circumstances where he determines it is in the best interests of the City to do so in which case he shall advise the City Commission of his intention to refuse the funding.

Section 3: That upon the Broward MPO's Complete Streets and Other Localized initiatives Program funding being awarded to the City, and the City Manager accepting said award, the appropriate City Officials are hereby authorized to execute an agreement along with any other applicable documents in a form acceptable to the City Manager and approved as to form and legality by the City Attorney.

Section 4: That this resolution shall be in full force and effect immediately upon its passage and adoption.

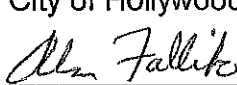
