A RESOLUTION OF THE CITY COMMISSION OF THE CITY APPROVING OF FLORIDA, HOLLYWOOD, AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A BLANKET PURCHASE AGREEMENT WITH CALVIN, GIORDANO & ASSOCIATES, INC. AND C.A.P. GOVERNMENT, INC. FOR INSPECTION AND PLAN REVIEW SERVICES IN AN AMOUNT UP TO \$4,500,000.00 FOR A THREE-YEAR TERM, FROM AUGUST 27, 2025, THROUGH MAY 15, 2028, BASED UPON THE CITY OF **FORT** LAUDERDALE CONTRACT 360-1 NO. ACCORDANCE WITH SECTION 38.41(C)(5) OF THE PROCUREMENT CODE. (PIGGYBACK)

WHEREAS, in response to varying market conditions impacting permitting, the Department of Development Services requires the retention of multiple vendors to assist City staff for inspection and plan review services; and

WHEREAS, the desired services were competitively bid by the City of Fort Lauderdale through Invitation to Bid Event 360-1 on October 9, 2024, and awarded to Calvin, Giordano & Associates, Inc. and C.A.P. Government, Inc. under Contract number 360-1; and

WHEREAS, the current term of Contract Number 360-1 is from May 16, 2025, through May 15, 2028, with an option to renew the contract for a two-year term; and

WHEREAS, Calvin, Giordano & Associates, Inc. and C.A.P. Government, Inc. have agreed to extend to the City of Hollywood the same pricing under the terms and conditions set forth in Contract Number 360-1; and

WHEREAS, the period of performance during which the desired services will be a three-year term, from August 27, 2025, to May 15, 2028, with an option to renew the contract for a 2-year period for an amount up to \$4,500,000.00; and

WHEREAS, Section 38.41(C)(5) of the Procurement Code allows the Chief Procurement Officer to procure, without formal solicitation procedures, all goods, supplies, materials, equipment, and services that are the subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof ("piggyback"), provided that the goods, supplies, materials, equipment, or services are the subject of a price schedule negotiated by the entities listed above and is based strictly on competitive bids, quotations, or competitive proposals and not on any preference

and such utilization of other governmental entities contracts shall be permitted only during the term of the other governmental entity's contract; and

WHEREAS, the Director of the Department of Development Services and Chief Procurement Officer recommend that the City Commission approve and authorize the execution of a Blanket Purchase Agreement with Calvin, Giordano & Associates, Inc. and C.A.P. Government, Inc. for services for the three-year period from August 27, 2025, to May 15, 2028, in an amount up to \$4,500,000.00; and

WHEREAS, the not to exceed amount for each fiscal year is \$1,500,000.00 with an approximate breakdown of:

• Public Utilities: \$400,000.00

Planning and Zoning: \$200,000.00

Engineering: \$50,000.00Building: \$850,000.00; and

WHEREAS, a portion of the funding for this contract is available in the FY 2025 Operating Budget in account numbers 114.140301.52400.531170.000000.000.000, 442.400401.53600.531170.000000.000, 001.140401.51500.531170.000000.000, and 001.140202.51500.531300.000000.000.000 and will be budgeted in subsequent fiscal years' operating budgets subject to approval and adoption by the City Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the execution, by the appropriate City officials, of Blanket Purchase Agreements with Calvin, Giordano & Associates, Inc. and C.A.P. Government, Inc., together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

<u>Section 3</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
