Proposed Legislation:

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A QUITCLAIM DEED TO HENRY GRAHAM FOR THE SALE OF A CITY OWNED VACANT RESIDENTIAL LOT PARCEL ID NO. 514204013410, AS SURPLUS PROPERTY FOR \$5,500.00, SAID LOT LOCATED ON THE EAST SIDE OF 2309 SIMMS STREET.

Explanation:

This Resolution seeks authorization for the appropriate City Officials to approve and authorize the execution and delivery of a quit claim deed for a City-owned vacant residential lot located on the east side of 2309 Simms Street which is to be sold to Henry Graham for \$5,500.00. Previously, the Director of Real Estate had identified and classified nine (9) City-owned, vacant lots as surplus property and recommended that the various lots be sold to the highest bidder by quit claim deed in the condition “as is.”

One of the parcels contained on the list of City-owned, surplus properties, Parcel ID No. 514204013410, is located on the east side of 2309 Simms Street consisting of an estimated 25’ x 100’ vacant residential lot. Parcel ID No. 514204013410 has a Broward County Property Appraiser’s market value in 2014 of \$12,500 and, consequently, no appraisal is required by the City Charter prior to its sale.

On December 4, 2013, a Notice of Availability for Sealed Sale, Bid Number S-201, was announced and advertised by different media to the public and parties interested in submitting seal bids for the purchase of said surplus property.

In response, three (3) sealed bids were received for the property located on the east side of 2309 Simms Street. The bids were opened, reviewed, and evaluated on January 7, 2014. It was determined that Henry Graham had submitted the highest bid for the property in the amount of \$5,500.00. It was thereupon recommended that the surplus property located on the east side of 2309 Simms Street be sold to Henry Graham in the amount of \$5,500.00 with the purchaser to be responsible for claiming the land parcel and making payment of the bid amount and all applicable fees and closing costs.

Sale of the surplus property will benefit the City in that the subject property will be returned to the City's tax rolls, the City will receive the sales price of the surplus property, and all maintenance costs previously incurred by the City for the maintenance and upkeep of the surplus property will now become the responsibility of the new property owner. Proceeds from the sale of the surplus property are to be deposited into account #01.1200.00000.364.00220.
