In addition to the bid total, an estimated \$20,000.00 is requested to cover the cost of parts and/or materials on an annual basis.

The Department of Public Utilities determined that the bids submitted by Cedenos Comfort Cooling, LLC and Thermal Concepts, Inc. meet the specifications, terms and conditions of the bid and are the lowest responsive, responsible bidders.

The Director of Public Utilities and the Director of Procurement Services recommend that the City Commission approve awards to Cedenos Comfort Cooling, LLC of Davie, Florida, as the primary vendor (\$117,933.75), and Thermal Concepts, Inc. of Davie, Florida, as the secondary vendor (\$39,311.25), for an estimated total annual expenditure of \$157,245.00.

The term for services is for an initial two (2) year period with the right to renew for one (1) additional one (1) year period providing all terms, conditions and specifications remain the same, both parties agree to the renewal, and such renewal is approved by the City.

Funding for the attached Blanket Purchase Orders has been provided for in the fiscal year 2016 budget in account numbers 42.4001.00000.536.003117, 42.4011.00762.536.003117 and 42.4041.00782.536.005224; and will be budgeted in subsequent fiscal years.
