A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND ADOPTING A VOLUNTEER PROJECTS ON PUBLIC LAND POLICY FOR CITY-OWNED PROPERTY, INCLUDING WITHOUT LIMITATION SWALES, RIGHTS OF WAY, ALLEYS, PARKS AND FACILITY FOOTPRINTS.

WHEREAS, the City receives requests for volunteer projects on City owned property, but there currently exists no policy concerning such projects; and

WHEREAS, the City wishes to adopt a policy regarding volunteer projects on public land ("Policy"); and

WHEREAS, the Policy includes a project proposal ("Proposal") that should contain a scope of work; and

WHEREAS, the Proposal should include any volunteer identified City resources that are requested for the project and should meet overall City strategies or provide a need that is not currently funded; and

WHEREAS, the Proposal should be in accordance with current practices and protocols set forth by the City; and

WHEREAS, proposed projects will be reviewed by the Director of Parks, Recreation and Cultural Arts, Director of Public Works, and Director of Development Services, or their designees, and provides for an appeal process to the City Manager.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and adopts a Volunteer Projects on Public Land Policy for the City of Hollywood.
