

SECOND AMENDMENT TO SHIP FUNDING AGREEMENT

THIS SECOND AMENDMENT to that certain June 23, 2015 SHIP Funding Agreement and to that certain December 19, 2016 First Amendment (the "Agreement"), is hereby dated effective as of the _____ day of _____, 2018 (the "Effective Date") and is agreed to between the CITY OF HOLLYWOOD, a municipal corporation of the State of Florida, ("CITY"), and the CENTER FOR INDEPENDENT LIVING OF BROWARD, INC., a Florida not-for-profit corporation (CIL), and collectively referred to as the parties. It is hereby mutually covenanted and agreed by and between the parties hereto that said Agreement is amended upon the terms, covenants and conditions hereinafter set forth.

- 1. That Article 3 of the Agreement entitled "Term of Agreement " is amended and modified to read as follows:

The term of this Agreement shall commence upon complete execution by the Parties and shall end on ~~April 1, 2018~~ May 31, 2018 unless extended or terminated earlier as provided herein. The provisions relating to the monitoring, enforcement, auditing, indemnification, insurance, assurances and financial responsibility shall survive the expiration or earlier termination of this Agreement as set forth in Section 12.20 of this Agreement.

- 2. That Exhibit "C" of the Agreement entitled "Timetable/Schedule For Project FY 2014/2015" is hereby amended and modified as set forth in the attached revised Exhibit "C".

- 3. All other provisions of the Agreement shall be and remain the same and in full force and effect.
