

IN RECOGNITION OF DRINKING WATER WEEK

MAY 4-10, 2014

WHEREAS: WATER IS OUR MOST VALUABLE NATURAL RESOURCE; AND

WHEREAS: ONLY TAP WATER DELIVERS PUBLIC HEALTH PROTECTION, FIRE PROTECTION, SUPPORT FOR OUR ECONOMY AND THE QUALITY OF LIFE WE ENJOY; AND

WHEREAS: THE CITY OF HOLLYWOOD'S WATER TREATMENT PLANT PRODUCES AN AVERAGE OF 22 MILLION GALLONS PER DAY; AND

WHEREAS: THE DEPARTMENT OF PUBLIC UTILITIES PARTICIPATED IN THE ANNUAL "DROP SAVERS WATER CONSERVATION POSTER CONTEST", THIS YEAR JUDGING 3,000 ENTRIES; AND

WHEREAS: ANY MEASURE OF A SUCCESSFUL SOCIETY – LOW MORTALITY RATES, ECONOMIC GROWTH AND DIVERSITY, PRODUCTIVITY, AND PUBLIC SAFETY ARE IN SOME WAY RELATED TO ACCESS TO SAFE WATER; AND

WHEREAS: WE ARE ALL STEWARDS OF THE WATER INFRASTRUCTURE UPON WHICH FUTURE GENERATIONS DEPEND; AND

WHEREAS: EACH CITIZEN OF THE CITY OF HOLLYWOOD IS CALLED UPON TO HELP PROTECT OUR SOURCE WATERS FROM POLLUTION, TO PRACTICE WATER CONSERVATION, AND TO GET INVOLVED IN LOCAL WATER ISSUES; NOW
