A RESOLUTION OF THE CITY COMMISSION OF THE CITY **APPROVING** HOLLYWOOD. FLORIDA. AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE FIRST **AMENDMENT** TO THE CONTINUING PROFESSIONAL SERVICES AGREEMENT WITH ATKINSREALIS USA INC., D/B/A ATKINS NORTH INC., TO PROVIDE **PROFESSIONAL** ENGINEERING CONSULTING SERVICES FOR THE TRAFFIC CALMING PROGRAM FOR THE GENERAL OBLIGATION BOND TRAFFIC CALMING PROJECT FOR AN ADDITIONAL TWO-YEAR PERIOD.

WHEREAS, AtkinsRealis USA Inc., d/b/a Atkins North America, Inc. ("Atkins"), currently has a Continuing Professional Services Agreement ("Agreement") for civil, landscape, architecture, planning, and engineering services for future roadway and complete streets projects, which was approved by the City Commission on December 19, 2018, pursuant to Resolution No. 2018-400; and

WHEREAS, on March 4, 2020, the City Commission passed and adopted Resolution No. R-2020-56, authorizing appropriate City officials to issue an Authorization to Proceed to Atkins to provide professional engineering services for the establishment of a Traffic Calming Program ("Program") to address safety concerns raised by residents regarding vehicular speeding and cut-through traffic in their neighborhoods; and

WHEREAS, Atkins completed the initial scope of work under Phases 1 and 2 to study and prioritize the proposed locations for various traffic calming elements Citywide, which is to be included in the preparation of conceptual plans for construction; and

WHEREAS, on July 6, 2022, the City Commission passed and adopted Resolution No. R-2022-191, authorizing appropriate City officials to issue an Authorization to Proceed to Atkins to provide professional engineering services for the design, permitting and construction phase services for General Obligation Bond ("GOB") Traffic Calming Improvements Phase 1; and

WHEREAS, on December 6, 2023, the City Commission passed and adopted Resolution No. R-2023-379, authorizing appropriate City officials to issue an Authorization to Proceed to Atkins to provide professional engineering services for Phase 3 of the Traffic Calming Program, and to extend the Professional Services Agreement for an additional one-year period; and

WHEREAS, on October 23, 2024, the City Commission passed and adopted Resolution No. R-2024-342, awarding Invitation for Bid IFB-223-24-AR, Traffic Calming

Improvements GOB Districts 1-4 & 6 Speed Tables to The Stout Group, LLC, now under construction. The portion of the project consisting of roundabouts and roadway realignments is in final design and permitting with bidding anticipated in the fall of 2025; and

WHEREAS, the Atkins Professional Services Agreement was extended under the City Manager's authority for an additional 120 days, with an expiration date of June 13, 2025, and therefore, an extension of the Agreement is requested for an additional two-year period to allow sufficient time for completion of the GOB Traffic Calming Improvements Phase 1 project; and

WHEREAS, the Director of Design and Construction Management recommends that the City Commission approve and authorize the execution of the First Amendment to the Agreement with Atkins, for an additional two-year period or until June 14, 2027, to provide professional services for the GOB Traffic Calming Improvements project.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and incorporated in this Resolution.

<u>Section 2</u>: That it approves and authorizes the execution, by the appropriate City officials, of the First Amendment to the Agreement with Atkins for an additional two-year period or until June 14, 2027, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form by the City Attorney.

<u>Section 3</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
