A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE AUTHORIZATION TO PROCEED FOR THE ATTACHED WORK ORDER NO. CTA 13-04 BETWEEN CRAVEN THOMPSON & ASSOCIATES, INC. AND THE CITY OF HOLLYWOOD FOR PROFESSIONAL **TECHNICAL** SERVICES FOR THE DESIGN, PERMITTING, BIDDING, AND ENGINEERING SERVICES DURING UPGRADE OF SANITARY SEWER LIFT STATION E-2 LOCATED AT 1210 NORTH OCEAN DRIVE, A PROJECT IDENTIFIED IN THE 2007/2008 WASTEWATER SYSTEM MASTER PLAN, IN THE AMOUNT NOT TO EXCEED \$60,500.00 (CITY PROJECT NO. 13-8052).

WHEREAS, the 2007/2008 Wastewater System Master Plan identified the need to upgrade the existing pumps in Sewer Lift Station E-2 due to capacity limitation; and

WHEREAS, the Department of Public Utilities requested a proposal from Craven Thompson & Associates, Inc. to provide professional engineering services related to the design, permitting, bidding, and technical services during the upgrade of Sanitary Sewer Lift Station E-2; and

WHEREAS, Craven Thompson & Associates, Inc. submitted a proposal for the professional services in the amount not to exceed \$60,500.00; and

WHEREAS, Craven Thompson & Associates, Inc. and the City of Hollywood have a Professional Services Agreement for General Engineering Consulting Services for the water and sewer infrastructure projects, which was approved by the City Commission by Resolution R-2009-214 on July 15, 2009, and the agreement has a provision for insurance and indemnification that meets the City's requirements and gives the City the right to terminate for convenience; and

WHEREAS, the Administration recommends that the City Commission authorize the appropriate City Officials to execute the attached Authorization to Proceed for Work Order No. CTA 13-04 between Craven Thompson & Associates, Inc. and the City of Hollywood, together with such nonmaterial changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney, in an amount not to exceed \$60,500.00; and WHEREAS, funding for the Lift Station E-2 Upgrade Project was included in the FY 2013 CIP approved via Resolution No. R-2012-336; and

WHEREAS, funding for engineering services is available in account number 42.4000.86595.536.003121; and

WHEREAS, the estimated time to complete the professional services is six (6) months;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the issuance, by the appropriate City Officials, of the attached Authorization to Proceed for Work Order No. CTA 13-04 between Craven Thompson & Associates, Inc. and the City of Hollywood, together with such nonmaterial changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney.
