

RESOLUTION NO. R-CRA-2019-

A RESOLUTION OF THE HOLLYWOOD, FLORIDA, COMMUNITY REDEVELOPMENT AGENCY ("CRA"), AUTHORIZING APPROPRIATE CRA OFFICIALS TO ISSUE AN AMENDED BLANKET PURCHASE ORDER WITH DELTA PROPERTY MAINTENANCE, INC., RENEWING THE AGREEMENT FOR JANITORIAL SERVICES AT THE BEACH RESTROOMS AND CRA OFFICES FOR AN ESTIMATED ANNUAL AMOUNT OF \$171,000.00.

WHEREAS, the CRA identified a need for janitorial services at the beach public restrooms and CRA offices; and

WHEREAS, on December 8, 2015, Bid Number F-4489-16-RL was electronically advertised via BidSync in accordance with Section 38.42(A), City Code; and

WHEREAS, after all bids were evaluated, the CRA Executive Director and the Director of Procurement Services Division recommended that the CRA Board approve the award to Delta Property Maintenance ("DPM") for an estimated annual expenditure of \$75,888.00; and

WHEREAS, on January 20, 2016, pursuant to Resolution R-CRA-2016-03, the CRA Board approved a two-year agreement with the right to renew for two additional two-year periods providing that all terms, conditions and specifications remained the same, both parties agreed to the renewal, and such renewal was approved by the CRA; and

WHEREAS, on June 6, 2018, pursuant to Resolution R-CRA-2018-15, the CRA Board approved the amendment of Blanket Purchase Order B002828 to an increased annual amount of \$134,000.00; and

WHEREAS, due to the new construction of new restroom facilities located at Missouri Street and the garage located at Nevada Street that is presently under construction, the annual price for janitorial services has increased to an estimated annual amount of \$171,000.00; and

WHEREAS, funding for the increased estimated annual amount has been appropriated and exists in account number 163.638507.55200.531170.000000.000.000.

Section 2: That it approves and authorizes Blanket Purchase Order B002828 to be increased to an estimated annual amount of \$171,000.00 for the remaining term of the agreement.

Section 3: That this Resolution shall be in full force and in effect immediately upon its passage and adoption.
