A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE ATTACHED CONTRACT BETWEEN PRECISION ROOFING CORP. AND THE CITY OF HOLLYWOOD FOR ROOF REPLACEMENT ON THE WASHINGTON PARK COMMUNITY CENTER BUILDING, IN THE AMOUNT OF \$98,750.00.

WHEREAS, the Department of Public Works has determined that the roof above the Washington Park Community Center Building located at 5199 Pembroke Road, Hollywood needs to be replaced; and

WHEREAS, specifications and details to replace the roof were prepared by a City consultant and the Notice to Bidders was advertised online via BidSync on October 26, 2015; and

WHEREAS, these construction documents and specifications were viewed by twenty-eight (28) vendors on BidSync and seven (7) vendors downloaded the Project Manual and specifications; and

WHEREAS, through receipt of the City's bid specifications for this project, all contractors have been provided with a copy of the City's contract, including the terms and conditions contained therein; and

WHEREAS, four (4) bids were received and publicly opened at 10:00 AM on November 17, 2015, and the responsive bids are as follows:

WHEREAS, City staff reviewed the four (4) bids and determined that the bid submitted by Precision Roofing Corp. (Precision) was the overall lowest, responsive and responsible bid, and have recommended the award of the bid to Precision in the amount not to exceed \$98,750.00; and

WHEREAS, on November 18, 2015 the City Commission approved Resolution No. R-2015-345 which continued the appropriation for previously approved Capital Projects from FY 2015 to FY 2016 and provided funding for the Roof Replacement Project; and

WHEREAS, funding for the Roof Replacement at Washington Park Community Center Building is available in account numbers 34.5100.15452.519.006301 and 34.5114.14452.519.006301;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That it hereby approves and authorizes the execution, by the appropriate City Officials, of the attached contract between Precision Roofing Corp., and the City of Hollywood, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney.
