A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE A BLANKET PURCHASE AGREEMENT WITH BRANDANO DISPLAYS, INC. FOR CITY HOLIDAY DÉCOR AND LIGHTING IN AN ANNUAL AMOUNT UP TO \$248,910.00 IN ACCORDANCE WITH SECTION 38.41(C)(9) OF THE PROCUREMENT CODE. (BEST INTEREST)

WHEREAS, the Department of Public Works ("Public Works") desires to contract for City Holiday Décor and Lighting for the City's Hollywood Boulevard corridor, Downtown District, and Beach Broadwalk areas that serve as a major economic stimulus for the City, and create memorable experiences for residents and visitors, and promote community spirit and pride; and

WHEREAS, the Community Redevelopment Agency ("CRA") has been using Brandano Displays, Inc. ("Brandano") since 2019 and the transition between CRA and the Public Works will include the Department acquiring the responsibilities of holiday decorations and lighting; and

WHEREAS, Public Works has determined that it is in the best interest of the City to purchase City Holiday Décor and Lighting from Brandano due to the high quality of service with quick and efficient installation of the décor and lighting for the City in the past six years; and

WHEREAS, feedback from the community residents and visitors has been positive and encouraging, and Brandano has made the City a priority customer when it comes to serving the City's decorations and lighting needs; and

WHEREAS, the period of performance during which the desired Holiday Décor and Lighting will be acquired is over a one-year period with one additional one-year renewal term in an amount up to \$207,425.00 with a twenty percent contingency for a total amount of up to \$248,910.00; and

WHEREAS, Section 38.41(C)(9) of the Procurement Code states that when the City Commission declares by a five-sevenths (5/7ths) affirmative vote that competitive bidding and competitive proposals are not in the best interest of the City, such purchases are exempt from competitive bidding and competitive proposal requirements; and

WHEREAS, the Director of Public Works and Chief Procurement Officer recommend that the City Commission approve and authorize the issuance of a Blanket Purchase

Agreement with Brandano for City Holiday Décor and Lighting in an amount up to \$248,910.00; and

WHEREAS, funding for the Blanket Purchase Agreement is available in account number 001.500301.51900.531170.000000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves and authorizes the issuance, by the appropriate City officials, of a Blanket Purchase Agreement with Brandano together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

<u>Section 3</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
