A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE ATTACHED CONTRACT BETWEEN GIANNETTI CONTRACTING CORPORATION AND THE CITY OF HOLLYWOOD FOR CONSTRUCTION SERVICES RELATED TO THE WATER MAIN REPLACEMENT PROGRAM FROM SHERIDAN STREET TO PERSHING STREET AND FROM NORTH 22ND AVENUE TO NORTH 24TH AVENUE, AS IDENTIFIED IN THE 2007 WATER SYSTEM MASTER PLAN AND AS PART OF THE CITY-WIDE WATER MAIN REPLACEMENT PROGRAM, IN THE AMOUNT OF \$2,868,708.00 (CITY PROJECT NO. 13-5121).

WHEREAS, the 2007 Water System Master Plan identified the need to replace aging infrastructure throughout the City of Hollywood and to install additional infrastructure to improve the level of service within the City's water system; and

WHEREAS, the City-wide Water Main Replacement Program identified the need to replace old water distribution infrastructure and install 8-inch diameter and 4-inch diameter water mains within the area surrounded by Sheridan Street and Pershing Street and North 22nd Avenue and North 24th Avenue; and

WHEREAS, on September 18, 2013, via Resolution R-2013-266, the City Commission approved a proposal from Brown and Caldwell, Inc., in the amount of \$289,992.00, to provide engineering design services, permitting services, bidding recommendation services, and limited engineering services during construction for the Water Main Replacement Program within the area surrounded by Sheridan Street and Pershing Street and North 22nd Avenue and North 24th Avenue; and

WHEREAS, on February 17, 2015, the Department of Public Utilities staff advertised the project soliciting for qualified construction services, and on March 20, 2015, nine (9) bid proposals were received at the Office of the City Clerk and were publicly opened at the City of Hollywood Southern Regional Wastewater Plant with the following results:

WHEREAS, after thoroughly evaluating the bid proposals for compliance with the contract documents, City staff determines that the low bidder Giannetti Contracting Corporation is the lowest responsive, responsible bidder; and

WHEREAS, a Notice of Intent to Award related to the project was posted in the City of Hollywood web site, in DemandStar and in BidSync on March 23, 2015; and

WHEREAS, the posting of the Notice of Intent to Award resulted in no bid protests; and

WHEREAS, the Administration recommends that the City Commission authorize the appropriate City Officials to execute the attached contract between Giannetti Contracting Corporation and the City of Hollywood in the amount of \$2,868,708.00 for construction services related to the Water Main Replacement Program for the area surrounded by Sheridan Street and Pershing Street and North 22nd Avenue and North 24th Avenue; and

WHEREAS, funding for water main projects was included in the FY 2015 Capital Improvement Program that was approved via Resolution No. R-2014-356; and

WHEREAS, funding is available in account number 42.4000.76663.536.176301; and

WHEREAS, the estimated time for completion of construction is 365 calendar days from Notice to Proceed;

RESOLUTION TO EXECUTE THE ATTACHED CONTRACT BETWEEN GIANNETTI CONTRACTING CORPORATION AND THE CITY OF HOLLYWOOD FOR CONSTRUCTION SERVICES RELATED TO THE WATER MAIN REPLACEMENT PROGRAM FROM SHERIDAN STREET TO PERSHING STREET AND FROM NORTH 22ND AVENUE TO NORTH 24TH AVENUE, AS IDENTIFIED IN THE 2007 WATER SYSTEM MASTER PLAN AND AS PART OF THE CITY-WIDE WATER MAIN REPLACEMENT PROGRAM, IN THE AMOUNT OF \$2,868,708.00 (CITY PROJECT NO. 13-5121).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the execution, by the appropriate City Officials, of the attached agreement between Giannetti Contracting Corporation and the City of Hollywood, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney.

Section 2: That this resolution shall be in full force and effect immediately upon its passage and adoption.
