- Assist with Cityworks Mobile Applications
- Provide general troubleshooting support for Cityworks
- Ad-hoc Support as needed to assist with the functionality of Cityworks including support calls.

SECTION E. SCHEDULE

Services will be provided on an as-needed basis and will not exceed 52 weeks.
