A RESOLUTION OF THE CITY COMMISSION OF  
THE CITY OF HOLLYWOOD, FLORIDA, NAMING  
ROTARY FIELD 2 LOCATED AT ROTARY PARK,  
3150 TAFT STREET AS "DAVID SHULL FIELD".

WHEREAS, Subsection 155.14(H) of the City of Hollywood, Code of Ordinances provides for City Commission approval of the naming and renaming of streets and City facilities and for the establishment of application fees and procedures by resolution of the City Commission; and

WHEREAS, the City Commission, by Resolution Number R-2005-89 (as amended by R-2012-197), established Procedures for the Naming and Renaming of Properties, Facilities, Parks, and Memorials; and

WHEREAS, by a 5/7 vote the City Commission may waive the procedural requirements for naming/renaming properties, facilities and parks, namely: i) submitting an application and fee to the City Clerk; ii) referring the application to the Naming Committee; iii) Naming Committee's reviewing the application; and

WHEREAS, the City Commission, on February 5, 2014, by a 5/7 vote, agreed to exempt itself from these procedural requirements;

WHEREAS, David Shull lived in Hollywood his entire life and coached at Rotary Park for over 12 years, even coaching teams when no other coaches were available; and

WHEREAS, David and Suzy Shull have served on the Board of Directors for Youth Sports of Hollywood for the past 6 years and David has also umpired baseball and softball for several years; and

WHEREAS, David and Suzy Shull were both recognized and received the "Jerry Engelhard Achievement Award" last year for their tireless efforts and many hours of volunteering to help solidify the program; and

WHEREAS, David Shull has been instrumental in the success of Youth Sports of Hollywood throughout the years; and

WHEREAS, David umpired right up until the end, only missing the last week of the season succumbing to cancer; and

WHEREAS, the City Commission desires to name Rotary Field 2 in honor of David Shull;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: The City Commission hereby names Rotary Field 2, located at Rotary Park, 3150 Taft Street, as "David Shull Field".

Section 2: That this resolution shall be in full force and effect immediately upon its passage and adoption.
