PROJECT STATUS

PROJECT STATUS:

- All storm drainage work and tie-ins to the FDOT drainage system have been completed on every street.
- Conduit installation for the undergrounding of franchise utilities on the side streets is about 90% completed.
- Conduit tie-ins and installation of handholes is ongoing on the sidestreets.
- Directional drilling has begun on A1A for the undergrounding of franchise utilities. Currently working from Van Buren to Monroe.
- Streetscape construction has begun on Van Buren Street. We've completed the north sidewalk and are currently working on the south sidewalk. Roadway construction will begin after the south sidewalk is finished.

VAN BUREN STREET:

- Sidewalk Subgrade South Side - 9/25/2025 - 9/29/2025
- Paver installation south sidewalk - 9/25/2025 - 9/30/2025
- Roadway Construction to begin on 10/1/2025. Starting 10/1/2025 the entire roadway will be closed to vehicle traffic. Anticipate roadway construction to be 4-5 weeks depending on the weather.

RESIDENT OUTREACH AND COORDINATION

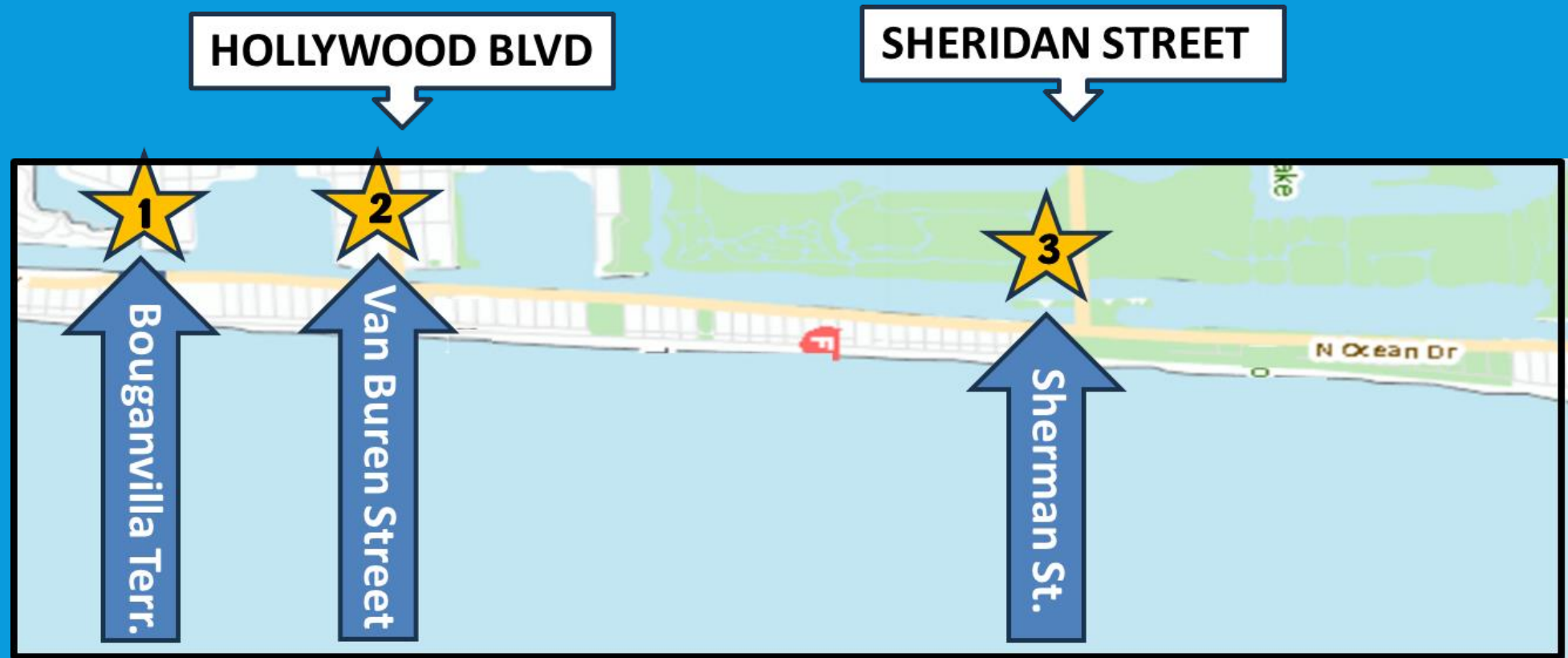
- Resident outreach and coordination is ongoing throughout the project.
