A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, CANCELLING THE REGULAR COMMISSION MEETING SCHEDULED ON MARCH 18, 2015, CHANGING THE REGULAR COMMISSION MEETINGS SCHEDULED IN JULY 2015, SCHEDULING A REGULAR COMMISSION MEETING ON AUGUST 26, 2015, AND CANCELLING THE JANUARY 6, 2016 COMMISSION MEETING.

WHEREAS, Section 2.04 of the Charter of the City of Hollywood provides, in relevant part, that the City Commission shall meet regularly not less than 20 times during the calendar year, at such times and places as shall be specified by Resolution; and

WHEREAS, pursuant to a series of resolutions, the City Commission has adopted its regular meeting schedule as the first and third Wednesdays of each month, except during the month of August; and

WHEREAS, the City Commission desires to cancel the regularly scheduled March 18, 2015 meeting; and

WHEREAS, the City Commission desires to change the regularly scheduled July 1, 2015 meeting to July 8, 2015, and to cancel the regularly scheduled July 15, 2015 meeting; and

WHEREAS, the City Commission desires to schedule a regular Commission Meeting on Wednesday, August 26, 2015; and

WHEREAS, the City Commission desires to cancel the regularly scheduled January 6, 2016 meeting;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the second regular meeting of the Hollywood City Commission scheduled on March 18, 2015 shall be cancelled.

Section 2: That the first regular meeting of the Hollywood City Commission during July, 2015 shall take place in the City Commission Chamber at City Hall, 2600 Hollywood Boulevard, on Wednesday, July 8, 2015 at 1:00 PM.

A RESOLUTION CHANGING THE DATES OF THE COMMISSION MEETINGS.

Section 3: That the second regular meeting of the Hollywood City Commission scheduled on July 15, 2015 shall be cancelled, and a regular meeting shall take place in the City Commission Chamber at City Hall, 2600 Hollywood Boulevard, on Wednesday, August 26, 2015 at 1:00 PM.

Section 4: That the first regular meeting of the Hollywood City Commission during January, 2016 shall be cancelled.

Section 5: Thereafter, regular meetings of the City Commission shall, unless otherwise provided by Resolution, be held on the first and third Wednesdays of each month.

Section 6: That this resolution shall be in full force and effect immediately upon its passage and adoption.
