We have worked closely with the City and the Legislature to demonstrate the need to secure funding to replace the City's aging water system. As a result of our advocacy, \$985,210 was appropriated to the City, an amount significantly above the City's initial ask, which allowed this critical project to be expedited.

Accomplishments Achieved on Behalf of Local Governments

Economic Development

During the legislative session, Jonathan's estimated hours will be 2 hours per week.

Paul Lowell will assist Jonathan in the management of activities conducted on behalf of the City. Paul's field of expertise includes home rule issues, local mandates, funding opportunities, legislative practice and procedure, legal analysis, and issues related to



sovereign immunity. During the legislative session, Paul's estimated hours will be 3 hours per week.

Cesar Fernandez field of expertise includes appropriations projects and substantive policy. During the legislative session, Cesar's estimated hours will be 2 hours per week.

Mario Bailey's field of expertise includes infrastructure and water projects, FDEP and FDEM grants, and legislative appropriations projects. During the legislative session, Mario's estimated hours will be approximately 5 hours per week.

Gerard O'Rourke's field of expertise includes transportation-related substantive and appropriations issues, as well as all FDOT issues. During the legislative session, Gerard's estimated hours will be approximately 2 hours per week.

Anticipated Municipal Staff Support

We anticipate that, based on our experience, from time to time, we may need to engage experts on staff with City to discuss specific issues with staff and elected leaders, such as with water and infrastructure projects. In addition, we anticipate regular communication with the City manager before, during, and after the Legislative Session, on an as-needed basis.

Firm's Ability to Meet the Requirements of the Scope of Work

In every action we take on the City's behalf, we will proceed with integrity and in full compliance with local, state, and federal laws and regulations. We believe our firm possesses the demonstrated experience, relationships, knowledge of urban issues, and knowledge of the legislative and executive branches of Florida state government to fully perform the requirements of the Scope of Work and General Responsibilities specified in the RFP.

In addition, we will provide opportunities for the City to connect with relevant legislative leaders to promote your priority policy issues and appropriations requests.

Regarding the City's 2022 legislative priorities contained in Attachment A to the RFP, we believe these issues are fully within the expertise of our team members, including:

State Policy

- Home rule/preemption: In recent years, as local government preemption has become a priority of the Legislature, particularly the House, we have worked closely with numerous local government clients to advise on and mitigate these proposals. These issues include:
 - Regulation of community redevelopment agencies.
 - Limitations on the assessment of impact fees.
 - o So-called local government ethics "reform."
 - So-called local government fiscal "transparency."
 - Regulations related to comprehensive plans and agricultural enclaves.
- **Regulation of short-term rentals:** Our team members have extensive experience with the short-term rental issue, related to the lengths of stay and tax collections.
- Anchoring limitation areas: Our firm was significantly involved with SB 1946 during the 2021 Legislative Session, as we represented the Village of Key Biscayne in ensuring that they would be able to maintain a preexisting exclusion zone.
- **Sovereign immunity and claim bill reform:** We are very familiar with issues related to sovereign immunity and the claims bill process. In particular, Paul



Lowell was a staff director for the Claims Committee while in the House, while Jonathan Kilman and Paul Lowell have worked on issues related to sovereign immunity at the state level.

• Current state funding:

Serving as a member of the Council has provided him with in-depth knowledge of preparing for social, environmental, and economic disturbances related to changes in climate, such as sea-level rise, flooding, and more.

- **Funding opportunities:** We regularly work with clients to identify funding opportunities at the state level, including FRDAP and BMFAP, and would be pleased to assist the City in identifying and securing such opportunities.
- Coordination with relevant state agencies: We have excellent working relationships with a number of state agencies, including FDOT, DEP, DEM, and DEO, and look forward to putting these relationships to work on behalf of the City.

Local Policy and Funding

- Beach funding: As noted above, we have worked to procure funding for BMFAP projects on DEP's priority list through the legislative appropriations process, and we look forward to lending our expertise related to funding and permitting of such projects.
- **Use of TDT taxes:** We have assisted and advised local governments regarding the use of TDT taxes for various local purposes.
