- Exterior site work including but not limited to re-sloping and grading of existing berm, provide SOD to match existing grass cover in accordance with the Contract Documents.

Shown below are our remarks based on documents provided by each bidder:

**Caliste Construction LLC**

Based on the documents provided Caliste construction LLC. has the most years of experience with projects varying from \$16,828 to \$1,462,220. Bidder provided multiple project reference with similar scope. However bidder failed to produced certificate of liability insurance as part of bid package.

**Pheonix Fence Corp.**

Based on the documents provided Phoenix Fence Corp. Has 2 years of experience. Past project reference provided by bidder shows only fence construction projects, though bidder included window replacement project reference by bidder's subcontractor for the project.

**VPR Construction Corp.**

Based on the document provided, VPR Construction corp. has 9 years of experience. Bidder Provided 5 past projects including 3 projects with similar scope and included 3 ongoing projects with one project with similar scope.

Based on the documents provided by the bidders, VPR Construction Corp. submitted the lowest bit as well as provided sufficient information to indicate relevant experience related to scope of work. Hence, we recommend VPR Construction Corp. to be the most appropriate to be awarded with the contract.
