A RESOLUTION OF THE CITY COMMISSION OF THE CITY HOLLYWOOD, FLORIDA, **APPROVING** AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE MISCELLANEOUS **APPROPRIATIONS** GRANT AGREEMENT WITH THE HOLLYWOOD ART AND CULTURE CENTER, INC. FOR THE PROVISION OF THROUGH CULTURAL SERVICES VISUAL ARTS. PERFORMING ARTS AND **EDUCATIONAL** PROGRAMMING IN THE AMOUNT OF \$205,000.00.

WHEREAS, the Hollywood Art and Culture Center, Inc. ("HACC") has the capability of providing cultural services to the public through its visual arts, performing arts and educational programming; and

WHEREAS, HACC has provided cultural services and has been a recipient of previous appropriations for such services; and

WHEREAS, Fiscal Year 2025 funding assisted in supporting educational programs that provided unique curriculum-based activities for all ages, including summer arts camps; and

WHEREAS, the City wishes to enter into a new agreement with HACC to provide these services for Fiscal Year 2026; and

WHEREAS, funding for the agreement is available in account number 001.300601.57200.531170.000000.000; and

WHEREAS, in addition to this grant, HACC provides services for the City by coordinating and managing the cultural arts programming services at the Hollywood Central Performing Arts Center, for which it receives \$70,000.00.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A MISCELLANEOUS APPROPRIATIONS GRANT AGREEMENT WITH THE HOLLYWOOD ART AND CULTURE CENTER, INC. FOR THE PROVISION OF CULTURAL SERVICES THROUGH VISUAL ARTS, PERFORMING ARTS AND EDUCATIONAL PROGRAMMING IN THE AMOUNT OF \$205,000.00.
