A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, RATIFYING THE SUBMISSION OF AN APPLICATION FOR THE 2024 JUSTICE ASSISTANCE GRANT PROGRAM; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ACCEPT THE GRANT IN THE AMOUNT OF \$36,856.00; AUTHORIZING APPROPRIATE CITY OFFICIALS TO EXECUTE ALL APPLICABLE GRANT DOCUMENTS; AMENDING THE FISCAL YEAR 2025 OPERATING BUDGET.

WHEREAS, the Police Department submitted an application for the 2024 Edward Byrne Memorial Justice Assistance Grant program to assist with the purchase of Automated External Defibrillators (“AEDs”); and

WHEREAS, AEDs can save lives by delivering electric shocks to the heart, and this portable equipment allows officers to have quick access to life-saving technology that can benefit the community by aiding in life safety efforts; and

WHEREAS, the Broward Sheriff’s Office is the local facilitating law enforcement agency and distributes the funds to each local law enforcement agency; and

WHEREAS, acceptance of the grant does not require a contribution of matching funds; and

WHEREAS, the Chief of Police recommends that the appropriate City officials accept the Justice Assistance Grant funds from the Department of Justice in the amount of \$36,856.00 for the purchase of AEDs; and

WHEREAS, the Fiscal Year 2025 Operating Budget of the City of Hollywood was adopted and approved by the City Commission pursuant to Resolution R-2024-317 at the second Public Budget Hearing on September 18, 2024; and

WHEREAS, this Resolution seeks to amend the budget as detailed in the attached Exhibit “1”.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing “WHEREAS” clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it authorizes the appropriate City officials to apply for and accept the Department of Justice Edward Byrne Memorial Justice Assistance Grant in the amount of \$36,856.00.

Section 3: That the City Manager is authorized to accept the funds, provided that the City Manager shall have the discretion to refuse the grant in those circumstances where he determines it is in the best interest of the City to do so, in which case he shall advise the City Commission of his intention to refuse the grant.

Section 4: That it authorizes the appropriate City officials to execute all grant documents upon receiving the sub-grant funds, together with such non-material changes as may be acceptable to the City Manager and approved as to form by the City Attorney.

Section 5: That these Amendments to the Operating Budget of the City of Hollywood for the Fiscal Year beginning October 1, 2024 relating to the Police Grants Fund (Fund 113) and set forth in detail in the attached Exhibit "1" are adopted and authorized as Amendments to the Operating Budget of the City of Hollywood for the Fiscal Year 2025.

Section 6: That the Department of Financial Services is authorized to establish such line-item accounts as may be necessary to properly monitor and track appropriations.

Section 7: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
