A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE ATTACHED CONTRACT BETWEEN STRUCTURAL INTEGRITY CONTRACTORS, INC. AND THE CITY OF HOLLYWOOD FOR VAN BUREN PARKING GARAGE STRUCTURAL REPAIRS, IN THE AMOUNT OF \$219,833.00.

WHEREAS, Parking Administrative staff identified the need to have a Condition Survey completed on the Van Buren Parking Garage; and

WHEREAS, as a result of that Condition Survey, construction documents and specifications to make the necessary structural repairs were prepared by a Consultant and the Notice to Bidders was advertised online via BidSync on November 9, 2016; and

WHEREAS, these construction documents and specification were viewed by seventy-six (76) vendors on BidSync and twenty-three (23) downloaded them; and

WHEREAS, a Non-Mandatory Pre-Bid Meeting was held at the site on November 30, 2016 to review the existing conditions on site; and

WHEREAS, through receipt of the City's bid specifications for this project, all contractors have been provided with a copy of the City's contract, including the terms and conditions contained therein; and

WHEREAS, NINE (9) bids were received and publicly opened at 10:00 AM on December 8, 2016, and the responsive bids are as follows:

WHEREAS, City staff reviewed the nine (9) bids and determined that the bid submitted by Structural Integrity Contractors, Inc. was the overall lowest, responsive and responsible bid, and have recommended the award of the bid to Structural Integrity, Inc. in the amount not to exceed \$219,833.00; and

WHEREAS, On October 5, 2016 the City Commission approved R2016-291 R2016-291 which continued the appropriation for previously approved capital projects from FY2016 to FY2017 and included the funding for the Garage Repairs and Maintenance project which is available in account no. 46.1100.14192.545.006301, 46.1100.12176.545.006301 & 46.1100.15192.545.006301;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That it hereby approves and authorizes the execution, by the appropriate City Officials, of the attached contract between Structural Integrity Contractors, Inc., and the City of Hollywood, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney.
