A RESOLUTION OF THE CITY COMMISSION OF THE CITY

WHEREAS, the City of Hollywood Artwork Selection Committee ("Committee") was created in June 1994 to review, select and display appropriate artwork, including photography, loaned or donated to the City for exhibition on the walls of the foyers and corridors of City Hall at 2600 Hollywood Boulevard, Hollywood, Florida; and

WHEREAS, the duties of the Committee include reviewing artwork that could be acquired by the City through commission, donation, or purchase for placement within City facilities; and

WHEREAS, Resolution R-2018-171 was amended to increase the membership of the Committee from nine to ten members, to include a Student Member and an Art and Culture Center Representative; and

WHEREAS, the Committee is comprised of Members who are from the artistic and cultural community, are associated with artists in various media in Florida, and have leadership in numerous cultural organizations, which is an essential component when selecting board members to attract new talent to City Hall; and

WHEREAS, presently Cathleen Dean, Laszlo Nador, Fred Villers-Furze and Zachariah White serve on the Committee, and their terms expire on June 30, 2025; and

WHEREAS, there is a vacant, not filled position and that expires on June 30, 2027; and

WHEREAS, the Student Member position is vacant as it was not filled and expires on June 30, 2027; and

WHEREAS, presently Meaghan Kent serves as the Art and Culture Center Member and her term expires on June 30, 2025; and

WHEREAS, the City Clerk provided notice to the public that positions were available and solicited interest forms from the community to fill the current vacancies; and
