A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS ТО EXECUTE THE ATTACHED CONSULTANT'S AUTHORIZATION TO PROCEED (ATP) BETWEEN CRAVEN THOMPSON AND ASSOCIATE, INC. AND THE CITY OF HOLLYWOOD PROVIDE PROFESSIONAL SURVEYING TO AND MAPPING SERVICES FOR THE DESIGN OF THE ALLEY RECONSTRUCTION PROJECTS IN AN ESTIMATED AMOUNT OF \$55,620.00.

WHEREAS, in 2013, the City hired Transmap Corporation to perform a Pavement Management Study which identified the number of alleys requiring reconstruction Citywide; and

WHEREAS, surveying services are required to assist the Department of Public Works with the in-house design of the Alley Reconstruction Project; and

WHEREAS, on October 19, 2011, the City Commission passed and adopted Resolution No. R-2011-269 which authorized the negotiation and execution of agreements on a rotating basis with the three (3) highest ranked firms to provide professional services for surveying and mapping services projects for initial three (3) year terms with an option to renew for two (2) additional one (1) year terms; and

WHEREAS, subject to the City Commission's approval on February 4, 2015, of Resolution R-2015-____ approving the first year's renewal of the three agreements for the provision of professional surveying and mapping services; and

WHEREAS, Craven Thompson and Associate, Inc., one of the ranked firms, was asked to provide surveying services related to the in-house design of the Alley Reconstruction Projects identified in the Pavement Management Study; and

WHEREAS, the City desires to move forward with professional surveying and mapping services for twenty-nine (29) alleyway segments as previously identified and needed for the design of the alley resurfacing project.; and

WHEREAS, the Director and Deputy Director of the Department of Public Works recommend that the City Commission authorize the appropriate City Officials to execute the attached Consultant's Authorization to Proceed between Craven Thompson and Associate, Inc. and the City of Hollywood, in an estimated amount of \$55,620.00; and

WHEREAS, On October 15, 2014, the City Commission adopted R-2014-301 which continued the appropriation for previously approved Capital Projects from FY 14

to FY 15 and included funding for Alley Resurfacing. Funds are available in account # 34.1400.14484.541.006303;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1:</u> That it hereby approves and authorizes the execution, by the appropriate City officials, of the attached Consultant's Authorization to Proceed (ATP) between Craven Thompson and Associate, Inc. and the City of Hollywood, in an estimated lump sum amount of \$55,620.00, together with such nonmaterial changes as may be subsequently agreed to by the City Manager and approved as to form and legality by the City Attorney.

<u>Section 2:</u> That this resolution shall be in full force and effect immediately upon its passage and adoption.
