A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A BLANKET PURCHASE AGREEMENT WITH CAY INDUSTRIES, INC., D/B/A PRINT DYNAMICS, FOR THE NEW HORIZONS NEWSLETTER FOR AN ESTIMATED ANNUAL AMOUNT OF \$130,084.00 BASED UPON BID NUMBER IFB-4751-22-SK FOR NEWSLETTER PRINTING AND MAILING SERVICES.

WHEREAS, the Office of Communications, Marketing and Economic Development ("CMED") desires to purchase printing, list and mail preparation services for the City's New Horizons Newsletter; and

WHEREAS, the City posted Invitation for Bid Number IFB-4751-22-SK for Citywide Newsletter Printing and Mailing Services ("Bid") on August 22, 2022, which closed on September 21, 2022; and

WHEREAS, the Bid asked suppliers to provide pricing for services including printing, list and mail preparation outlined in the responsible and responsive section of the Bid; and

WHEREAS, a total of two bids were received from the following vendors:

Cay Industries, Inc. d/b/a Print Dynamics - \$130,084.00

Original Impressions LLC - \$131,866.20 ; and

WHEREAS, Cay Industries, Inc., d/b/a Print Dynamics ("Print Dynamics"), has satisfactorily performed these services for the City in the past; and

WHEREAS, the Director of CMED and the Chief Procurement Officer recommend that the City Commission authorize the execution of the attached Blanket Purchase Agreement with Print Dynamics for a two-year period, with the option to renew for up to two additional two-year periods, in the annual amount of \$130,084.00; and

WHEREAS, award is subject to the City's receipt and approval of all insurance certificates and endorsements required by the City's Risk Manager; and

WHEREAS, funding for this Blanket Purchase Agreement is available in account number 557.113001.51900.531170.000000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves and authorizes the execution, by the appropriate City officials, of the attached Blanket Purchase Agreement with Cay Industries, Inc., d/b/a Print Dynamics, together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

<u>Section 3</u>: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
