A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE A PURCHASE ORDER TO CARVILLE CHRYSLER DODGE JEEP RAM FOR 10 DODGE DURANGO PURSUIT VEHICLES IN AN AMOUNT UP TO \$486,500.00 IN ACCORDANCE WITH SECTION 38.41(C)(9) OF THE PROCUREMENT CODE. (BEST INTEREST)

WHEREAS, the Police Department desires to purchase pursuit vehicles to replace aging pursuit vehicles; and

WHEREAS, the Police Department has determined that it is in the best interest of the City to purchase 10 Dodge Durango pursuit vehicles from Carville Chrysler Dodge Jeep Ram due to their available inventory of pursuit vehicles that City staff is having difficulty obtaining from other vendors; and

WHEREAS, the Police Department is experiencing ongoing difficulty in sourcing vehicles due to supply-chain issues in the car industry; and

WHEREAS, Section 38.41(C)(9) of the Procurement Code states that when the City Commission declares by a five-sevenths (5/7ths) affirmative vote that competitive bidding and competitive proposals are not in the best interest of the City, such purchases are exempt from competitive bidding and competitive proposal requirements; and

WHEREAS, the Chief of Police and Chief Procurement Officer recommend that the City Commission authorize the issuance of a Purchase Order to Carville Chrysler Dodge Jeep Ram for 10 Dodge Durango pursuit vehicles in an amount up to \$486,500.00; and

WHEREAS, funding for the Purchase Order was included in the amended FY 2024 Capital Improvement Plan and is available in account number 557.209901.51900.564520.001761.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:
