This is a notice of the City of Hollywood's intent to award a contract. The responsible and responsive offeror(s) whose bid(s)/proposal(s) was determined in writing to be the most advantageous is indicated. The offeror (s) identified herein is instructed not to proceed with incurring any expenses and/or providing any goods/services until a contract or other form of agreement is executed by the City. Any such action without an executed contract will be at the sole risk of the offeror(s).

**NOTE:** Award is being recommended in aggregate to the lowest responsive/responsible primary, secondary and tertiary bidders. Work orders / purchase orders issued under the secondary contract will be issued when the primary vendor is unable to perform or when the City determines that the primary vendor's maximum service capacity has been reached (based on outstanding city purchase orders) and additional service capacity is still needed by the City to meet the city's service timeframes. The aforementioned procedure will be followed for the tertiary contract.

**Protest:** Any actual or prospective bidder who is aggrieved in connection with this pending award of the contract or any element of the process leading to an award may protest to the Director (Chief Procurement Officer) of the Office of Procurement and Contract Compliance. Pursuant to Protests procedures in <u>Section 38.52</u> of the City of Hollywood Code of Ordinances, a protest must be filed within five (5) business days of this posting or any right to protest is forfeited. The protest must be in writing, must identify the name and address of the protester, and must include a factual summary of, and the basis for, the protest. Filing shall be considered complete when the protest, including the protest deposit described

below, is received by the Office of Procurement and Contract Compliance by the aforementioned deadline via hand delivery or certified mail at the following location: *City of Hollywood, Office of Procurement and Contract Compliance, 2600 Hollywood Blvd., Room 303, Hollywood, FL 33020*.

**Protest deposit:** A deposit is required from the protester to compensate the City for the expenses of administering the protest. If the protest is decided in the protester's favor, the entire deposit shall be returned to the protester. If the protest is determined to be without merit, the deposit shall be forfeited to the City. The deposit shall be in the form of cash or a cashier's check and shall be in the amount of 1% of the amount of the pending award, or \$3,500, whichever is greater.
