A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A BLANKET PURCHASE AGREEMENT WITH HENRY SCHEIN, INC. FOR THE PURCHASE OF MEDICAL AND SURGICAL SUPPLIES IN AN ESTIMATED ANNUAL AMOUNT UP TO \$255,217.08.

WHEREAS, the Department of Fire Rescue desires to purchase medical supplies to deliver emergency medical services; and

WHEREAS, Section 38.43 of the Procurement Code states that when the estimated annual cost of goods, supplies, materials, equipment, or services exceeds \$50,000.00, a formal solicitation process shall be completed that may result in a written contract(s) and/or purchase order(s) after due public notice inviting bids or proposals; and

WHEREAS, on January 25, 2024, Invitation for Bid Number IFB-167-24-GJ ("IFB") was electronically advertised on OpenGov.com to solicit Medical and Surgical Supplies in accordance with Section 38.43(A) of the Procurement Code; and

WHEREAS, the IFB resulted in bids from the following eight vendors by the response due date:

WHEREAS, upon further review, Bound Tree Medical, LLC did not provide pricing for all line items requested; and

WHEREAS, Henry Schein, Inc. was determined to be the lowest responsive and responsible bidder, providing pricing for all items; and

WHEREAS, the Fire Chief recommends that the City Commission authorize the issuance of a Blanket Purchase Agreement to Henry Schein, Inc. to provide medical and surgical supplies, on an as needed, when needed basis, in an estimated annual amount up to \$255,217.08 for an initial three-year term, with the option to renew for two additional one-year periods; and
