

RESOLUTION NO. R-CRA 2019-

A RESOLUTION OF THE HOLLYWOOD, FLORIDA, COMMUNITY REDEVELOPMENT AGENCY ("CRA"), AUTHORIZING APPROPRIATE CRA OFFICIALS TO ISSUE A CONTRACT TIME EXTENSION, WITHOUT INCREASE OF COSTS, FOR THE NEVADA PARKING GARAGE, TO BE COMPLETED BY SEPTEMBER 25, 2019.

WHEREAS, the Nevada Parking Garage Project includes construction of a new parking garage; and

WHEREAS, on July 3, 2017, the CRA Board awarded Kaufman Lynn Construction Inc. a Construction Management contract in the amount of \$13,109,688.00 to construct a new parking garage located between Nebraska and Nevada Streets on A1A; and

WHEREAS, due to unforeseen soil condition issues at the new parking garage site between Nevada and Nebraska Streets, there is a need for a time extension of the contract for the Nevada Parking Garage without an increase of costs; and

WHEREAS, the requested contract time extension will require project completion by September 25, 2019; and

WHEREAS, the Executive Director of the CRA recommends approval of the time extension.

NOW, THEREFORE, BE IT RESOLVED BY THE HOLLYWOOD, FLORIDA COMMUNITY REDEVELOPMENT AGENCY:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the execution, by the appropriate CRA officials, of a contract time extension without an increase of costs for the Nevada Parking Garage project, to be completed by September 25, 2019.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
