

PERPETUAL PARKING EASEMENT AGREEMENT

THIS PARKING EASEMENT (the "Parking Easement") made this _____ day of March, 2024, granted by HOLLYWOOD BEACH LLC, a Florida limited liability company ("North Property Owner"), with an address at 1001 East Atlantic Avenue, Suite 202, Delray Beach, Florida 33483, in favor of OCEANSIDE MARINA LLC, a Florida limited liability company ("South Property Owner").

WHEREAS, the South Property Owner is the owner of those parcels of real property more particularly described on Exhibit A attached hereto and by this reference made a part hereof (collectively, the "Oceanside Marina Adjacent Parcels"); and

WHEREAS, the North Property Owner is the owner of those parcels of real property more particularly described on <u>Exhibit B</u> attached hereto and by this reference made a part hereof (collectively, the "<u>Hollywood Beach Adjacent Parcels</u>"); and

WHEREAS, the North Property Owner, an affiliate of the South Property Owner, has agreed to grant the South Property Owner and its Permittees, as defined below, a perpetual non-exclusive easement to utilize those portions of the Hollywood Beach Adjacent Parcels which are designated from time to time for parking (the "Easement Area") more particularly described as follows, to-wit:

Lots 1, 2, 3, 4 and 5, in Block B of HOLLYWOOD BEACH SECOND ADDITION, according to the Plat thereof, as recorded in Plat Book 4, Page 6, of the Public Records of Broward County, Florida, less and except the East 12.5 feet thereof, previously dedicated as additional right-of-way for North Ocean Drive (A1A).

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor and Grantee hereby agree as follows:

1. Recitals.

The foregoing recitals are true and correct, are incorporated herein by reference,

and form an integral part of this Parking Easement.

2. **Grant of Easement.**

The North Property Owner does hereby grant the South Property Owner, its successors and assigns and its Permittees, upon the conditions hereinafter set forth, a perpetual non-exclusive easement (the "Parking Easement") to utilize the Easement Area for the parking of motor vehicles and for pedestrian and vehicular ingress and egress in connection therewith. "Permittee(s)" shall mean the members, managers, employees, agents, contractors, customers, visitors, invitees, licensees and concessionaires of the South Property Owner and their successors and assigns.

3. **Term of Parking Easement**.

The term of this Parking Easement shall be perpetual.

4. Use Limitations.

The South Property Owner shall use the Easement Area solely for the parking of motor vehicles and for pedestrian and vehicular ingress and egress in connection therewith and the South Property Owner shall not be entitled to utilize the Easement Area for any other use or purpose without the written approval of the North Property Owner, which approval shall not be unreasonably withheld, conditioned or delayed. The Easement Area shall in no event be blocked or closed, altered, changed or removed (the foregoing shall not be deemed to include maintenance, repairs, restriping etc. or temporary closures to effect same), unless required by applicable laws

5. **Maintenance.**

The South Property Owner shall pay to the North Property Owner for the use of the Easement Area the maintenance cost of the Easement Area.

6. **Appurtenant Easement**.

This Parking Easement is an easement appurtenant to the Oceanside Marina Adjacent Parcels and shall inure to the benefit of South Property Owner, and its successors and assigns, and shall run with the title to the Oceanside Marina Adjacent Parcels.

7. **Not Subject to liens.**

The interest of the South Property Owner in the Easement Area and the interest of the North Property Owner in the Hollywood Beach Adjacent Parcels shall not be subject to liens arising from the use of the Easement Area by the South Property Owner and/or the Permitees or the exercise by the South Property Owner and/or the Permitees of the rights granted hereunder.

The South Property Owner shall promptly cause any lien which it causes to be imposed against the Easement Area to be discharged or transferred to bond.

8. **Indemnity**.

The South Property Owner, its successors and assigns shall indemnify, defend and hold the North Property Owner harmless from and against any damages, liability, actions, claims or expenses (including reasonable attorney's fees and expenses at trial and all appellate levels) arising out of exercise of the rights granted hereby by any person whomsoever, including, without limitation, loss of life, personal injury and/or damage to property arising from or out of any occurrence in or upon the Easement Area or in connection with the use or operation of the Easement Area by the South Property Owner and/or the Permitees or exercise by the South Property Owner and/or the Permitees of the rights granted by this Parking Easement.

9. **Insurance**.

The South Property Owner shall provide, maintain and keep in full force and effect general liability insurance in an amount not less than Two Million Dollars (\$2,000,000) per occurrence, combined single limit bodily injury and property damage liability coverage, and workers' compensation covering all employees in accordance with Chapter 440 Florida Statutes. In addition, Grantee shall maintain business automobile liability at a limit of liability not less than \$1,000,000 each occurrence for all owned, non-owned and hired automobiles.

Except for workers' compensation, all insurance policies shall name the North Property Owner as additional insured. Such insurance shall be issued by an insurance company licensed to do business in the State of Florida. A certificate of insurance evidencing such insurance coverage shall be provided to the North Property Owner prior to the use of the Easement Area by the South Property Owner and such certificate shall require at least thirty (30) days prior notice of cancellation or adverse material change in coverage.

In no event shall the limits of said insurance policies be considered as limiting the liability of the South Property Owner under this Parking Easement. Furthermore, the South Property Owner shall and hereby does hold the North Property Owner harmless from any loss or damage incurred or suffered by the North Property Owner due to the failure of the South Property Owner to maintain such insurance.

10. **No Dedication**

The grant of easement contained herein is for the use and benefit of the South Property Owner, its successors, and assigns and the Permittees and is not intended and shall not be construed as a dedication to the public of any portion of the Easement Area for public use.

11. **Run with Land**

All of the benefits, burdens, covenants and agreements herein shall constitute covenants running with the land, shall be binding upon and/or shall accrue to the benefit of and be binding upon the North Property Owner and the South Property Owner and their respective successors and assigns, having or hereafter acquiring any right title or interest in or to all or any portion of the Hollywood Beach Adjacent Parcels or the Oceanside Marina Adjacent Parcels.

12. Recordation and Amendments.

This Perpetual Parking Easement Agreement shall be construed under the laws of the State of Florida. This Perpetual Parking Easement Agreement and any amendments hereto shall be recorded in the Public Records of Broward County, Florida. This Agreement may only be modified, supplemented or revised in writing signed by the parties, or their successors or assigns, and any modification shall be effective only upon recordation in the Public Records of Broward County, Florida. This Perpetual Parking Easement Agreement shall not be modified, amended or released unless approved by the City Manager or his/her designee.

13. Termination.

In the event that North Property Owner and/or the South Property Owner desire to sell or otherwise transfer title of their respective properties to a third party, both parties shall submit proper documentation, in a form acceptable to the City, evidencing that the parking requirements are satisfied through the use of alternative sites. Such documentation must be submitted and approved by the City prior to any sale or transfer of title. No use may be made of the subject properties until the required parking requirements are satisfied by the use of such replacement parking. Such documentation shall be recorded in the public records of Broward County, Florida. Upon recordation of the new parking documentation, this Perpetual Parking Easement Agreement shall be terminated and released by the City.

12. **Assignability**.

This Parking Easement is an easement appurtenant to the Hollywood Beach Adjacent Parcels and may not be transferred or assigned separately or apart from the Hollywood Beach Adjacent Parcels.

13. **Remedies**.

In the event either party fails or refuses to perform any term, covenant, or condition of this Parking Easement for which a specific remedy is not set forth in this Parking Easement, the other party shall, in addition to any other remedies provided at law or in equity, have the right of specific performance and injunctive relief.

14. Subject to Matters of Record.

This Parking Easement is granted without warranty or representation and subject to zoning and other governmental restrictions, matters reflected on any plat relating to the Easement Area, and all other easements, restrictions, conditions, encumbrances and other matters of record.

15. **Miscellaneous**.

This Parking Easement shall be governed by, construed and enforced in accordance with, the laws of the State of Florida. Venue in any action, suit or proceeding in connection with this Easement shall be in a state court of competent jurisdiction in Broward County, Florida. No party shall be considered the author of this Parking Easement since the parties hereto have participated in extensive negotiations and drafting and redrafting of this document so as to arrive at a final agreement. Thus, the terms of this Parking Easement shall not be strictly construed against one party as opposed to the other party based upon who drafted it. In the event that any section, paragraph, sentence, clause, or provision hereof or the application thereof to any person or circumstance, shall be determined to be unenforceable by a court of competent jurisdiction (the "Offending Provision"), then the remainder of this Parking Easement, or the application of such term, covenant or condition to persons, entities or circumstances other than those as to which it is invalid or unenforceable, shall not be affected thereby and each term, covenant and condition of this Parking Easement shall be valid and enforced to the fullest extent permitted by law; provided, however, that the parties affected by the Offending Provision shall endeavor in good faith, within sixty (60) days after the date such determination is made, to agree upon alternative provisions which shall have the same practical effect as the Offending Provision and upon any agreement being reached, the new provision shall be incorporated into and form a part of this Parking Easement. This Parking Easement contains the entire understanding and agreement of the parties with respect to the subject matter hereof. No amendment shall be effective unless the same is in writing and signed by all parties.
