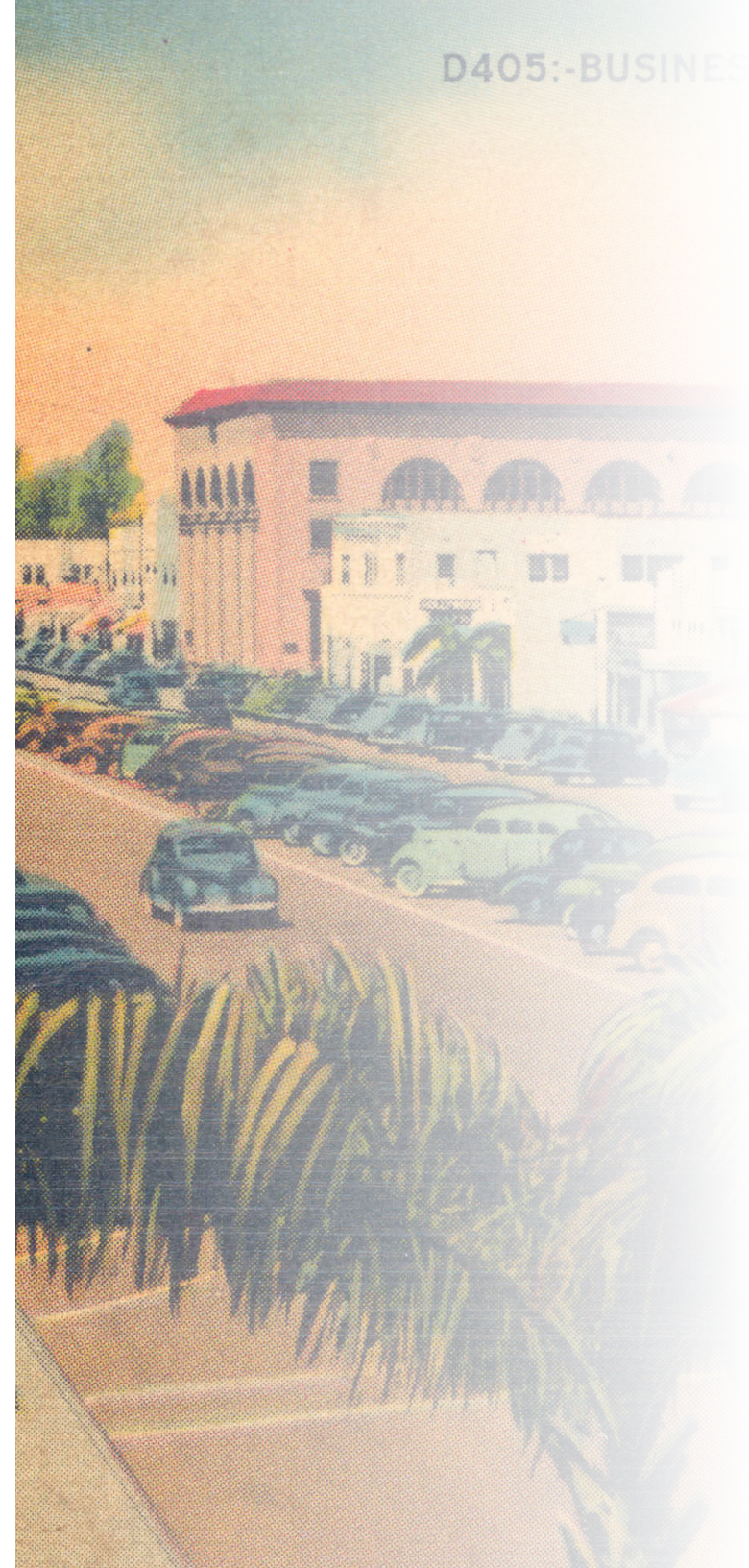

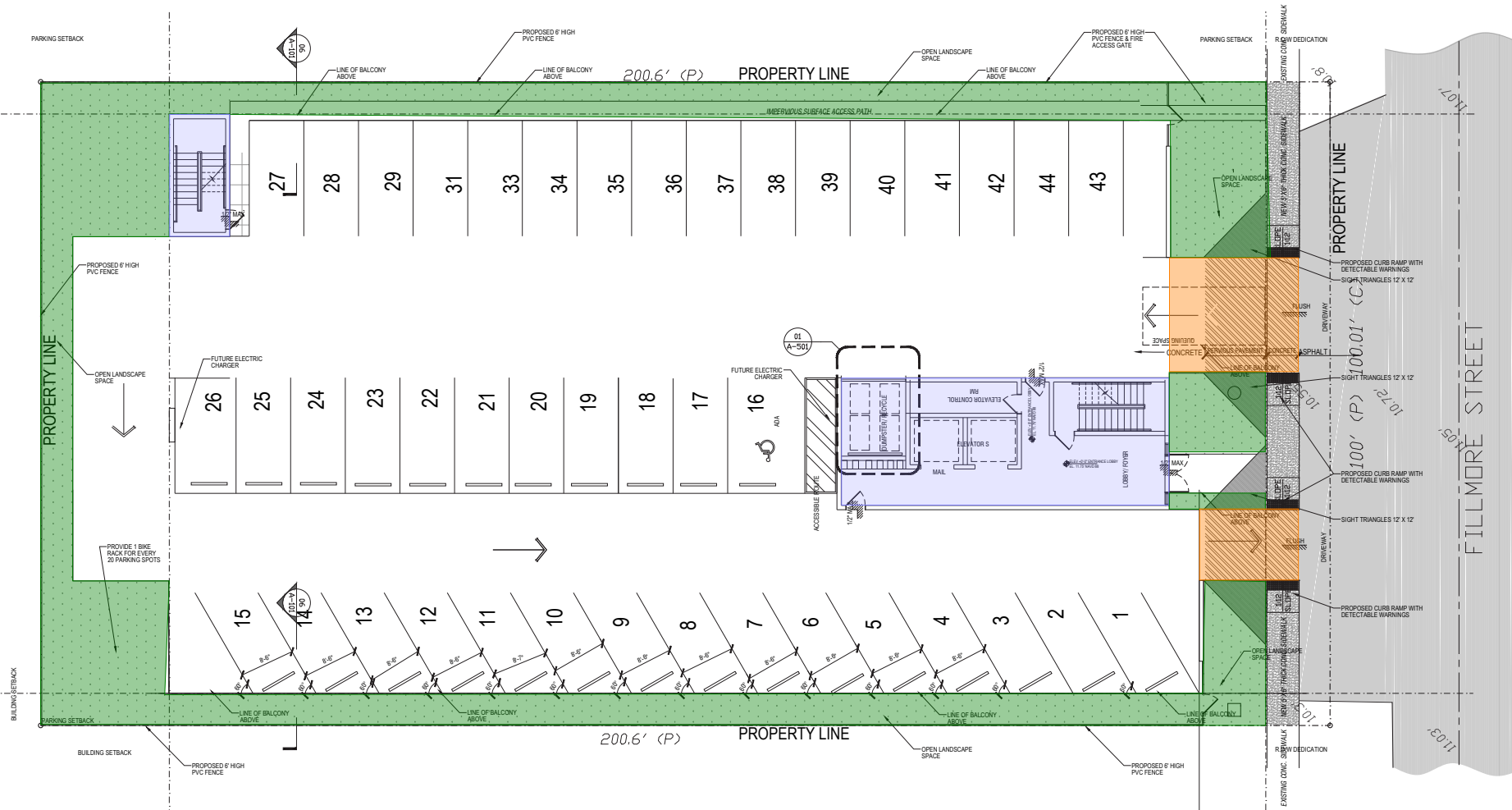

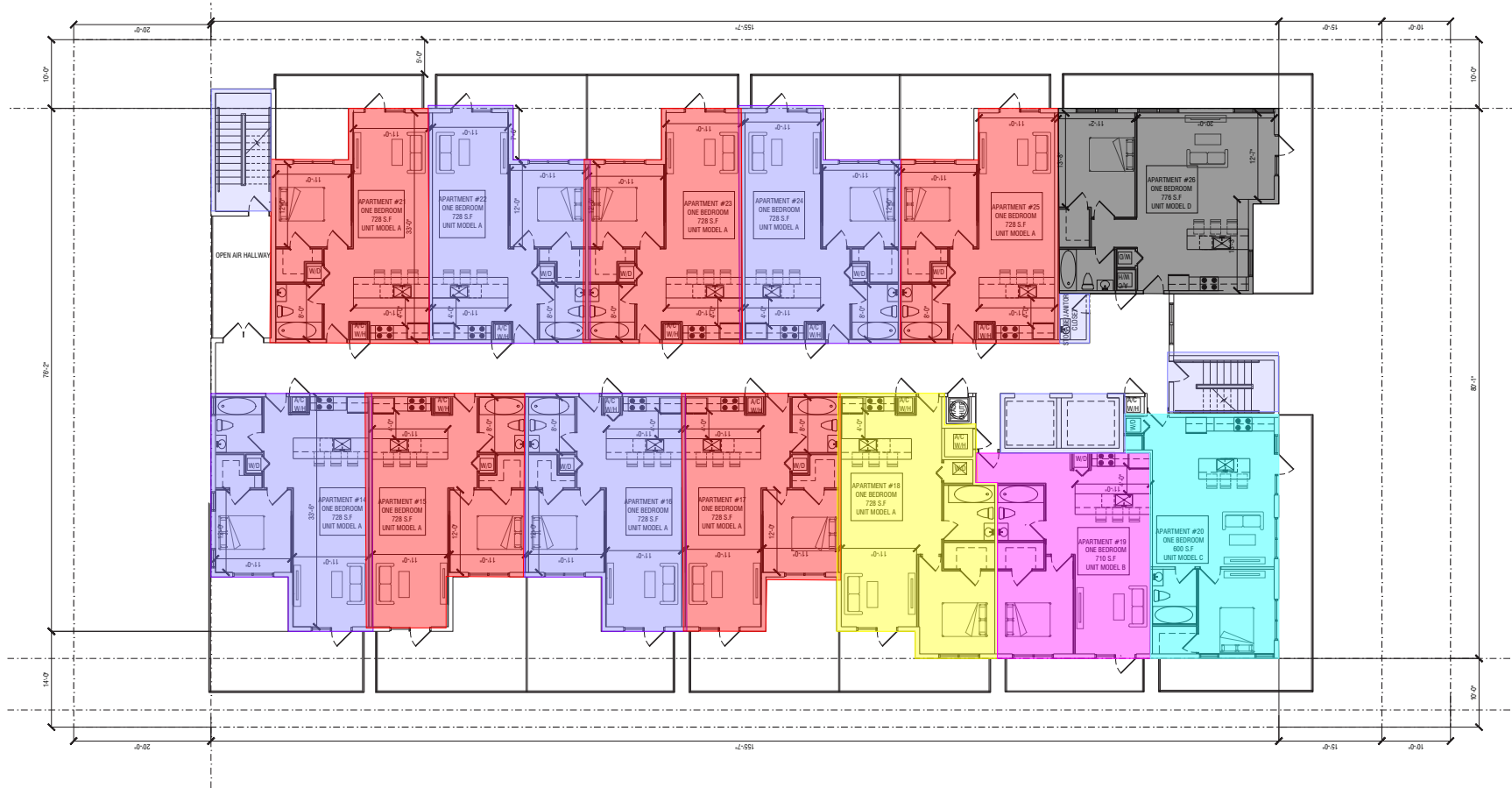
# PROPOSED TYPICAL UNIT FLOOR PLAN

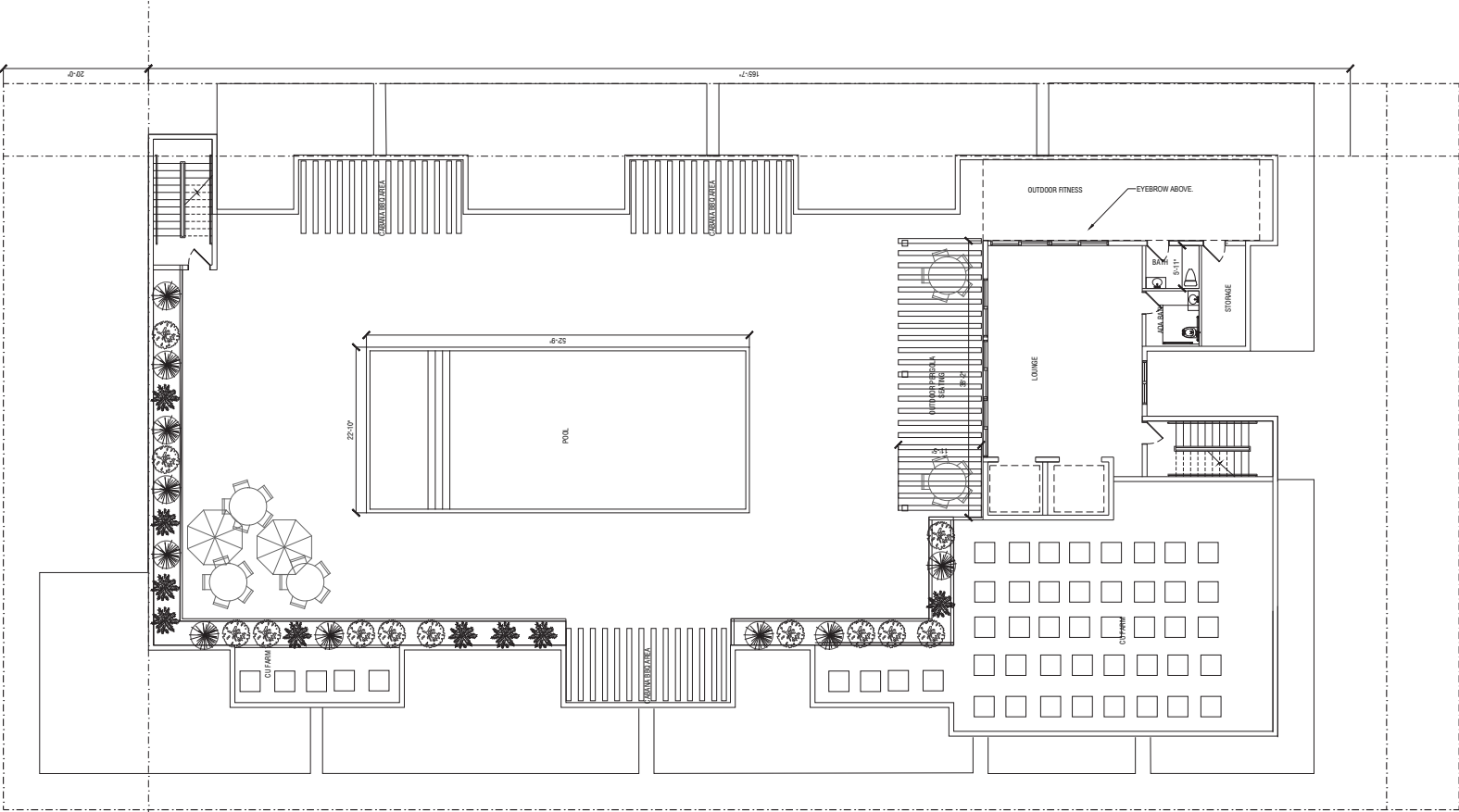

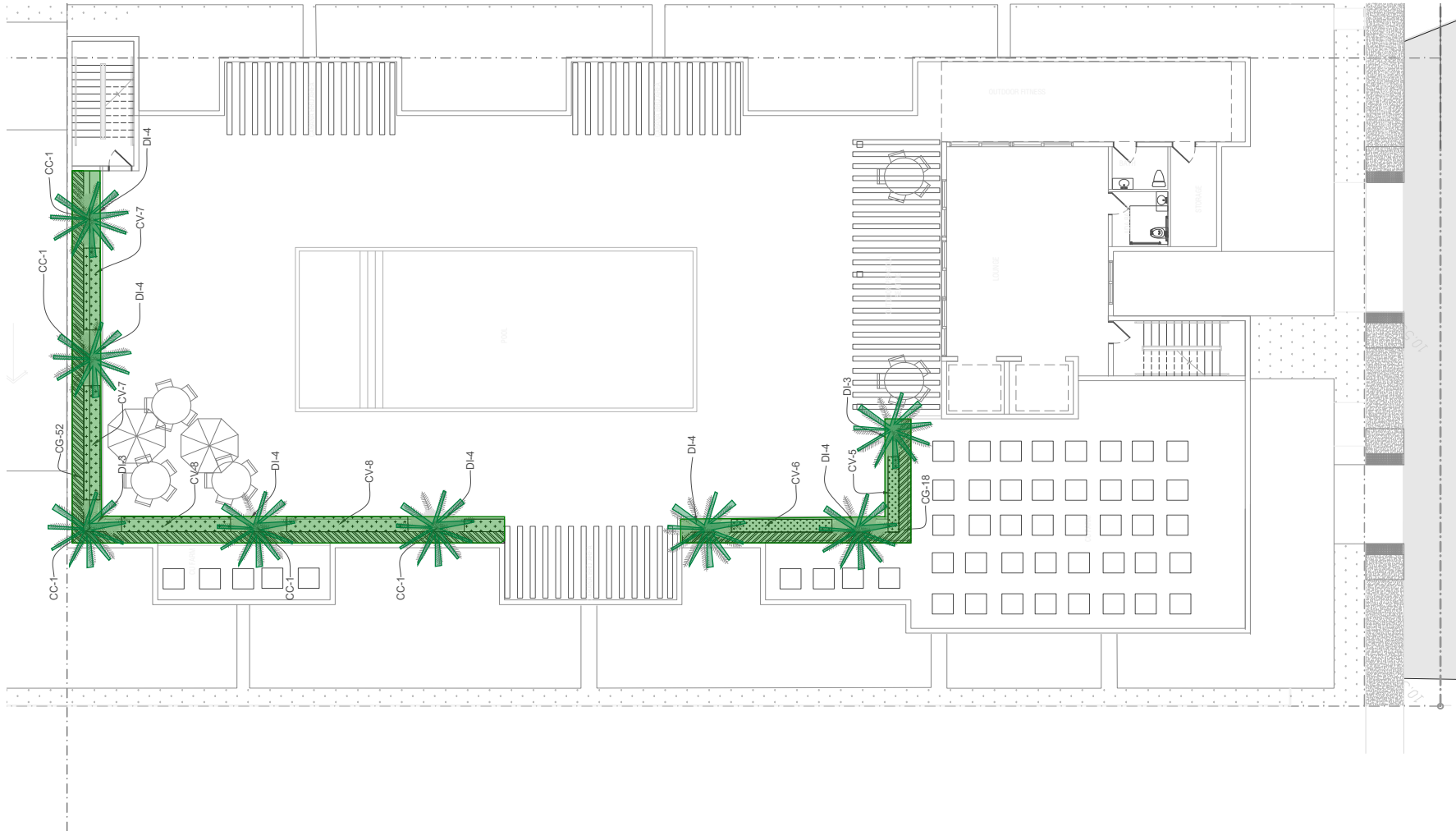
