

RESOLUTION NO. R-2024-025

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE INITIAL CHANGE ORDERS TO CONTRACTS WITH SOUTHEASTERN ENGINEERING CONTRACTORS, INC. AND RIC-MAN INTERNATIONAL, INC. FOR CONSTRUCTION SERVICES RELATED TO ON-CALL AND EMERGENCY WATER AND SEWER UTILITY REPAIR SERVICES, IN AN AMOUNT UP TO \$1,000,000.00 PER CONTRACT.

WHEREAS, on November 2, 2022, the City Commission passed and adopted Resolution No. R-2022-337, approving two contracts in an amount up to \$1,000,000.00 per contract with Southeastern Engineering Contractors, Inc. ("SEC") and Ric-Man International, Inc. ("Ric-Man") for construction services related to on-call and emergency water and sewer utility repair services for an initial term of two years each; and

WHEREAS, the Department of Public Utilities ("Department") desires to issue change orders to the above-mentioned contracts to increase the total amounts from \$1,000,000.00 to \$2,000,000.00 per contract, since the original contract amounts have been nearly exhausted in the first year; and

WHEREAS, the change orders will allow the Department to continue to repair its water distribution and sewer collection system infrastructure, when emergencies occur or as otherwise needed to prevent substantial threat to life, property, or the environment, until the initial terms of the contracts end on January 3, 2025; and

WHEREAS, Section 38.48 of the Procurement Code states that all change orders that the City Manager is not authorized to approve must be formally approved by the City Commission, which includes the desired change orders; and

WHEREAS, the Director of the Department recommends that the City Commission approve and authorize initial change orders to contracts with SEC and Ric-Man to increase the amounts from \$1,000,000.00 to \$2,000,000.00 per contract; and

WHEREAS, funding for the change orders was included in the amended FY 2024 Capital Improvement Plan, and is available in account number 442.409901.53600.546301.001650.000.000.

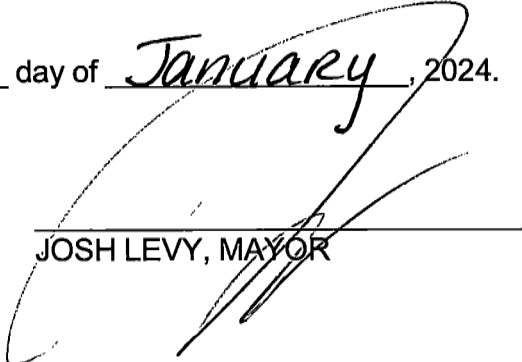
NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the execution, by the appropriate City officials, of change orders to contracts with SEC and Ric-Man, together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form by the City Attorney.

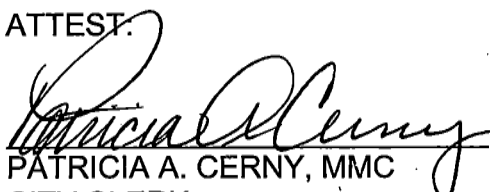
Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
