A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, ADOPTING A FIVE-YEAR CONSOLIDATED PLAN FOR FEDERAL PROGRAM YEARS 2024/2025 TO 2028/2029, AND ANNUAL ACTION PLAN AND PROJECTED USE OF FUNDS FOR FEDERAL PROGRAM YEAR 2024/2025.

WHEREAS, the City has been designated as an entitlement city by the U.S. Department of Housing and Urban Development ("HUD"); and

WHEREAS, HUD has mandated that all entitlement cities submit a Consolidated Plan, including an Annual Action Plan, governing housing and community development needs within its jurisdiction; and

WHEREAS, the City utilized U.S. Census data, locally adopted planning documents, and its public participation process to formulate a Five-Year Consolidated Plan and Annual Action Plan; and

WHEREAS, both the City Commission and the Community Development Advisory Board ("CDAB") are committed to priorities that give maximum benefit to low and moderate income families, preserve the quality of the City's housing stock, and aid in the elimination of slum and blight; and

WHEREAS, HUD has allocated \$1,234,567.00 in Community Development Block Grant ("CDBG") funds for the City, and the City has estimated the receipt of \$220,300.00 in CDBG Program Income for use in Federal Program Year 2024-2025; and

WHEREAS, HUD has allocated \$517,547.00.00 in the Home Investment Partnership Act ("HOME") funds for the City of Hollywood, and the City has estimated the receipt of \$1,500,000.00 in HOME Program Income for use in Federal Program Year 2024-2025; and

WHEREAS, on December 13, 2023, the CDAB held an advertised joint public hearing to obtain citizen input during the development of the Five-Year Consolidated Plan for federal program years 2024/2025-2028/2029 and the Annual Action Plan, which included the potential use activities eligible for funding for Fiscal Year 2024-2025; and

WHEREAS, on May 8, 2024, the CDAB reviewed and evaluated the proposed Five-Year Consolidated Plan for federal program years 2024/2025 to 2028/2029 and the Annual Action Plan and, subject to minor revisions and the inclusion of activities eligible for funding for Fiscal Years 2024-2025, have forwarded a recommendation of approval to the City Commission; and

WHEREAS, on June 12, 2024, the City held an advertised public hearing at the regularly scheduled CDAB meeting to obtain citizen input; and

WHEREAS, the following activities represent the recommendations of staff and the CDAB for Fiscal Year 2024-2025, which are subject to City Commission approval following a public hearing:

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

<u>Section 2</u>: That it approves, adopts, and authorizes submission, by the appropriate City officials, of the attached Five Year Consolidated Plan for Federal Program Years 2024/2025-2028/2029 and Annual Action Plan for Federal Program Year 2024-2025 commencing on October 1, 2024, including all of the attached assurances and certifications to the U.S. Department of HUD governing the CDBG and HOME programs, together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form by the City Attorney.

<u>Section 3</u>: That it certifies that the City will comply with all applicable federal laws, regulations, policies, guidelines, and requirements with respect to CDBG and HOME, including all assurances and certifications.

<u>Section 4</u>: That the City Manager or designee is authorized to execute the Five-Year Consolidated Plan and Annual Action Plan submission, all necessary certifications and funding agreements, and is designated to be the authorized representative of the City to act in connection with the Plan and to provide any additional information as may be required.

Section 5: The City Manager or designee is further authorized and directed to assume the status of the responsible federal official of the National Environmental Policy Act insofar as the provisions of the Act apply to this application.

That the City Manager or designee is authorized and directed to consent, on behalf of the City and himself, to accept jurisdiction of the federal courts for the purpose of enforcement of his responsibilities as a designated federal official.

Section 7: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
