A RESOLUTION OF THE CITY COMMISSION OF THE CITY
OF HOLLYWOOD, FLORIDA, REJECTING PROPOSALS
FOR RFQ-172-24-SK RELATED TO NETWORK
INFRASTRUCTURE CONSULTANT SERVICES.

WHEREAS, the Police Department is working to enhance its current network infrastructure and planned to retain consultant services for future projects; and

WHEREAS, on February 14, 2024, the City followed the formal solicitation procedures outlined in Section 38.43 of the Procurement Code to advertise RFQ-172-24-SK on www.OpenGov.com for network infrastructure consultant services; and

WHEREAS, the City received six proposals in response to RFQ-172-24-SK by the proposal due date of March 18, 2024; and

WHEREAS, on April 18, 2024, the Selection Committee for RFQ-172-24-SK evaluated the six proposals received in accordance with criteria established in the solicitation and shortlisted/ranked three vendors; and

WHEREAS, the Police Department entered negotiations authorized by R-2024-269 with two of the highest ranked vendors and determined the vendors to be non-responsible and over budget; and

WHEREAS, the Police Department has moved forward with alternate options for enhancing its current network infrastructure and chooses not to proceed with negotiations with the final ranked vendor, and the solicitation allows for the rejection of any and all responses; and

WHEREAS, Section 38.43(D) of the Procurement Code states that when any goods, supplies, materials, equipment or services shall be purchased and the estimated annual amount exceeds \$100,000, the Chief Procurement Officer shall have the authority to recommend to the City Manager, for City Commission consideration, the rejection or cancellation of all bids or proposals, or parts of all bids or proposals for any one or more goods, supplies, materials, equipment or services; and

WHEREAS, the Police Chief and Chief Procurement Officer recommend that the City Commission reject the proposals received in response to RFQ-172-24-SK for network infrastructure consultant services.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD,

Section 2: That City staff is directed to reject the proposals received in response
